### **Essential Employability Skills**

Proficiency in essential employability or "soft skills" are important abilities for our students and employees to have. College Career Readiness is a partner in the development of eight modules of employability skills training: **Critical and Analytical Thinking; Problem Solving and Decision Making; Cultural Sensitivity; Interpersonal Skills; Communication; Reliability and Dependability; Team Work; Time and Resource Management.** The modules are available in the NCCCS <u>Virtual Learning Community</u>.

Community college and community-based organization faculty and staff are encouraged to enroll their students in the modules or download the modules for use in Basic Skills instruction and courses. Revisions to the modules and assessments are being made to be effective spring 2020.

### **Basic Skills Plus Continues to GROW!**

The Basic Skills Plus Advisory Panel's hard work has provided guidance and strategies to help increase Basic Skills Plus student enrollment and to streamline program processes.

- The WIOA Providers' Guide has been updated with a key enhancement to Basic Skills Plus (BSKP), "students performing at the adult secondary education level on at least one NRS-approved assessment and who are co-enrolled in occupational and adult education courses while earning their adult high school diploma or a recognized high school equivalency credential are eligible for Basic Skills Plus waiver (pg. 33). The <u>Basic Skills Plus Implementation Guide</u> has also been updated (pg.5).
- We are in the process of reviewing Basics Skills Plus guidelines. Effective January 1, 2020, colleges do not need to submit a separate budget or application in the BS plus Registry. More information will be coming in February.

Thanks to all programs who responded to the BSKP survey (55% response rate). Input from the survey will be used by the Basic Skills Plus Advisory Panel to identify new strategies for increasing enrollment, credential attainment, career pathway development, and increasing student completion.

### **Basic Skills Plus Achievements**

- CCR's Basic Skills Plus program was identified in 2018 as a noteworthy practice by the monitoring team from the US Department of Education (Office of Career, Technical, and Adult Education).
- There are currently 72 approved career pathways in the online BSKP Registry; an increase of 76.6% from 2018 to 2019;
- Basic Skills Plus programs enrolled 191 students in 2018-19 for a 15.8 % increase from 2018 to 2019.
- Forty-four BSKP students graduated in 2018-19; 9 earned a High School Diploma and 35 earned a High School Equivalency Diploma.
- Basic Skills Plus students achieved a 63.1 % Measurable Skills Gain (MSG) in 1918-19. This level of achievement is 18.2 percentage points higher than the overall Title II MSG achievement of 44.9%.

### NC Economic Empowerment Curriculum Train-the Trainer

On December 5, 2019, eighty professionals from CCR, HRD, and CE participated in the NC Economic Empowerment Curriculum Train-the Trainer professional development at the Wake Technical Community College's Beltline Center Campus. The professional development program for adult education, workforce development, and like-minded adult service providers demonstrated the field-tested, customizable 6-hour Economic Empowerment Curriculum for adults with limited education and income. Highly flexible and multidisciplinary, this research and standards-based curriculum integrates basic economic concepts and reasoning skills throughout personal finance and entrepreneurship topics to help inform, develop, and empower economic decision-making skills within our workforce.
