#### **Huskins Dual Enrollment**

The purpose of the Huskins Bill cooperative program, called the Huskins Program, is to make available to high school students college level courses not otherwise available to them and to effect an uninterrupted education flow from the high school into the community college or four-year college or university.

#### Dual Enrollment

Dual Enrollment also known as "dual credit," or "concurrent enrollment," refers to the participation in college-level courses and the earning of college credits by high school students. Dual enrollment is viewed as providing high school students benefits such as greater access to a wider range of rigorous academic and technical courses.

#### Learn and Earn Online

Thanks to the leadership of Gov. Mike Easley and the NC General Assembly, North Carolina public high school students can earn college credits through a special Learn & Earn Online initiative beginning in the 2007-08 school year. Qualified students in participating public high schools can take a variety of online college-credit courses at no cost to them or to their families.

#### Minority Male Mentoring Coordinator Orientation

NCCCS Student Development Services sponsored an Orientation Program on January 29 -30, 2008 for 15 Community Colleges who received Minority Male Mentoring Grants this year. The Orientation Program was held at Wake Technical Community College's Western Campus. The orientation program provided participants with program expectations, minority mentoring program best practices, and several information sessions.

Presentations were made to the group by Dr. Tyrone Bledsoe, Executive Director/Founder of the Student African-American Brotherhood; Mr. Theodis Beck, Secretary, NC Department of Commerce; Ms. Annie Harvey, Warden, NC Correctional Institution for Women; and Dr. Graham Watt, Department of Commerce, Division of Workforce Development. Other presentations included a panel discussion on the "Challenges and Benefits of Operating a Minority Male Mentoring Program." The panel consisted of NCCCS pilot Minority Male Mentoring Program Coordinators, Mr. Ray Burrell, Wayne CC; Dr. Grova Bridgers, Johnston CC; and Mr. Demetrius Thompson, Durham Technical CC. An interactive "Dimensions of Diversity" session was conducted by Mrs. Charletta Sims Evans.

The Community College System Office is excited about the level of commitment and enthusiasm from both the new and pilot Minority Male Mentoring Program Coordinators.

#### - Minority Male Mentoring Conference

The North Carolina Community College System (NCCCS) will host the 4<sup>th</sup> annual Minority Male Mentoring Conference April 7-9, 2008, at the Sheraton Imperial Hotel and Convention Center in Durham, North Carolina.

The conference theme is entitled "Changing the Image of Education: A Call to Action!" Best practices and programming to improve minority male presence in education, family, and community life will be the focus of this event. Participants will be divided into groups and charged with creating a strategic action plan. Organizations may use the action plan as a blue print to establish yearly objectives and measurements.

The conference is designed for students, educators, administrators, teachers, counselors, public service agencies, community leaders, and others who are responsible for developing mentoring programs or other programs to enhance the advancement of minority males in our communities. The conference registration fee of \$120.00 covers several meals, conference sessions, and conference materials. Conference participants are encouraged to register as soon as possible. #### Financial Aid Student Lender Workshop -

Due to recently proposed changes to the Federal Student Loan Programs, Financial Aid Administrators are mandated to expand lender options to their students. Administrators are also required to outline their process for choosing lenders for their lender list. NCCCS Student Development Services conducted a Lender Workshop on February 11, 2008 to assist college financial aid administrators with this process.

This workshop allowed lenders to present their benefits and default prevention initiatives. The workshop was designed to provide colleges with a forum to receive information that will assist them in choosing lenders. Colleges were not required to use the lenders who presented during the workshop, nor were any lenders endorsed by the NCCCS.

The Advocacy Award is presented to an individual who has committed themselves to promoting and implementing positive change and advocacy on their campus and in the community. The student who receives this award must demonstrate a willingness to take the lead when it comes to change and the ability to motivate others to embrace change.

#### Career Services Survey

The N3CSDPA Career Services Division is conducting a survey to gain information about the structures and operations of career services on your campus. The responses from this survey will give us insight on the ways your campus is meeting the career development needs of students. The responses will also help us identify topics of interest for future career services personnel training.



Results will be posted on the NCCCS website and presented at the N3CSDPA Counselor's Division conference in March. We hope the findings of this survey will encourage greater collaboration and networking among career counselors across the state.

Best Practices for Counseling Referrals Manual

This manual will be sent to campuses via e-mail later this semester. The manual is a compilation of best practices from 15 colleges. The manual also covers issues such as effective referral processes, understanding emotional distress, common causes of emotional distress, tips for recognizing emotionally distressed students, responding to emotional distress, and helpful resources.

#### Reception Honoring GSK Foundation Teaching Scholars

The NCCCS Office of Student Development Services will honor 15 student recipients of the GlaxoSmithKline (GSK) Foundation Teacher Preparation Scholarship on Thursday, March 27, 2008 during a banquet at the Sheraton Imperial Hotel, RTP, NC. The banquet will be held during the annual Spring N4CSGA Conference. Each scholar received a total of \$5,000 in scholarship funds.

The GlaxoSmithKline Foundation, Inc., the North Carolina General Assembly, and Bank of America contributed more than \$2 million dollars to establish an endowment within the North Carolina Community College Foundation to support an extended role for North Carolina community colleges in teacher preparation. The endowment funds annual scholarships to prospective teachers enrolled in community college degree programs tied to baccalaureate completion programs.

GSK Scholars are enrolled at Piedmont CC, Richmond CC, Nash CC, Mayland CC, Western Piedmont CC, Halifax CC, Surry CC, and Sampson CC.

#### SACS President is Keynote Speaker for MMM Conference

Dr. Belle Wheelan, SACS President, will serve as keynote speaker for the upcoming Minority Male Mentoring Conference. Dr. Wheelan will deliver the keynote address on Tuesday morning, April 8, 2008, during the General Session breakfast meeting which will be held from 8:30 a.m. to 10:00 a.m. Dr. Wheelan will also participate in a roundtable discussion with college presidents and senior level administrators immediately following the breakfast. Participants will have the opportunity to engage in an informal discussion regarding recertification, substantive change requirements, institutional practices, and other concerns. Representatives from colleges who are preparing for reaccreditation are encouraged to attend both sessions.

Dr. Wheelan began her tenure as president on July 24, 2005. Prior to working for SACS, she served as Secretary of Education for the state of Virginia and worked with the members of the Commission on Colleges to ensure that higher education in the South continued to provide quality programs that prepared students for the future.

Dr. Wheelan served as president of Central Virginia Community College beginning in 1992. She was the first African American woman to serve as president of a 2 or 4 year public institution of higher education in the Commonwealth of Virginia. Prior to her presidencies, she held faculty and administrative posts at the Portsmouth Campus of Tidewater Community College in Norfolk, Virginia, Thomas Nelson Community College in Hampton, Virginia, and San Antonio College, in San Antonio, Texas.
