SUBJECT: Basic Skills' Correctional Education Training

The Basic Skills' Correctional Education Training will focus on Learning Disabilities -- the Bridges to Practice Approach. Four individual training sessions will be held. Bridges to Practice: A Research-based Guide for Literacy Practitioners Serving Adults with Learning Disabilities from the National Institute for Literacy

Through activities and discussion, participants will explore learning disabilities awareness, characteristics, legal issues, and best practices for correctional programs. This training is appropriate for correctional instructors, counselors, coordinators and administrators.
