## COLLEGE INFORMATION SYSTEM ISSUES UPDATES MAY 7, 2008

## **CURRICULUM (CU) ISSUES**

#### **Combined Course Library**

The Combined Course Library (CCL) Change Management Group is completing the business requirements for the functionality of the CCL. Currently, the group is reviewing a list of 115 business requirements. Once approved by the team, the development of a more complete timeline and detailed specifications will begin.

#### **Data Quality and Training**

Several sets of classes have been offered to address some of the data quality issues as well as classes to introduce college staff members to the different types of data found in the CIS System. The addition of the Subject Manner Experts to the College User Support Team will help to address the issues of work flows and new hire training and support.

#### **Other Curriculum Issues**

Several System Change Requests (SCRs) have been released to address error report messages problems, and a Request for Change (RFC) has been opened to address the Dual Majors issue.

## **CONTINUING EDUCATION (CE) ISSUES**

The complete list of issues for Continuing Education was received by the System Office on April 21, 2008 from Sue C. Marion, 2008 NCCCAEA President. Dr. Saundra Williams communicated with Ms. Marion that the complete list of issues had to be prioritized before work could begin. According to Ms. Marion, the NCCCAEA Board will meet on Tuesday, April 28 to review and prioritize the list. After the list has been prioritized a cross-subject area team will be formed to address the issues.

## **BASIC SKILLS ISSUES**

The Department of Education Change Management Group had their initial meeting February 20–22, 2008. The purpose of this meeting was to address the issues from the federal audit. The team developed an initial set of 56 Business Requirements and has identified a number of changes to the Literacy Education Information System Data Collection Forms. After the form changes are finalized, a final set of Business Requirements will be developed. The team's next meeting is scheduled for May 22, 2008. After the business requirements are finalized, the team will work with the Associate Vice President of Basic Skills to address other areas of concern for the collegelevel Basic Skills Staff.
