## **MEMORANDUM**

- SUBJECT: Two Percent Budget Reversion Fiscal Year 2008-09

Today we received information from the Office of State Budget & Management (OSBM) that due to the nation's economic slowdown and OSBM's forecast for North Carolina for FY 2008-09, the Governor has directed OSBM to take the steps necessary to ensure that the budget is balanced on June 30, 2009. Toward that end, effective immediately our authorized budget will be reduced by two percent.

The attached spreadsheet reflects the budget reduction of two percent for each college. The reduction was calculated by multiplying each college's total allocation,<sup>1</sup> less estimated receipts and federal basic skills, vocational education, and Tech Prep receipts by two percent (2%). In addition, colleges are asked to hold in reserve an additional one percent (1%) in case further reversions are required later this year.

Funds that cannot be used as part of the reversion are salary increase funds and Customized Training funds. Colleges may revert Basic Skills and 920 Equipment as a *last resort*. Please submit reversions on Form 104 and indicate the appropriate purpose(s) and object description(s) (salary and/or other costs) from which funds are being reverted. If a college, as a last resort, reverts Basic Skills or 920 Equipment, make sure to note the justification in the appropriate area on the 104 form. **Reversions must be submitted to Brandy Andrews no later than Friday, October 17, 2008.**
