**RE: STATE BOARD CODE REORGANIZATION – PLEASE WIDELY DISTRIBUTE**

Effective July 1, 2011, the State Board of Community Colleges was a beneficiary of an exemption from the rule-making provisions of Chapter 150B. Due to this exemption, it became necessary for the State Board of Community Colleges to develop its own code that will be applicable to community colleges and proprietary schools. The Legal Affairs Department of the System Office (Legal Affairs) is responsible for spearheading the development of the State Board of Community Colleges Code (SBCC Code). To maximize the SBCC Code's effectiveness, it is necessary to re-structure the current code provisions to be more user-friendly, develop the State Board's new rule-making process, make current code provisions consistent with current legislation, update outdated rule provisions, and implement rules that are consistent with our System priorities.

Legal Affairs, with significant input from subject matter experts within the System Office, has revised the structure of the old Title 23 of the North Carolina Administrative Code. The new organizational structure is designed to make it easier to find applicable rule provisions, facilitate maximum space to add additional rules to the SBCC Code, and easily accommodate all of the impending substantive changes to current rule provisions.

Please note that the new organizational structure of the SBCC Code has new code numbers and a new citation format. There are also current rule numbers with no rule language attached. The absence of language from some rule numbers is intentional as these new rule

numbers were developed to accommodate new rule language that is forthcoming. While the new organizational structure of the SBCC Code has new code numbers for the provisions and new citation formats, as of today's date, **there have been no changes to any rule language that was in effect as of June 1, 2012.** Any changes to the language within any of the rule provisions will occur through the State Board's standard rule-making process. In other words, if there is a rule in the State Board Code that is currently outdated, that rule is still outdated in this new organizational structure. Legal Affairs has simply rearranged the structure of current rules to facilitate the substantive rule changes to come.

Effective today, colleges shall not use the "N.C.A.C." abbreviation when citing to the SBCC Code. The new citation format is "[Title number][Chapter letter] SBCCC [Subchapter number].[Rule number]." For example, because the "Admission to Colleges" rule is now located in Title 1, Chapter D, Subchapter 400, Rule number 2, the new citation format for the "Admission to Colleges" rule is "1D SBCCC 400.2."

The most current rules will be posted in the SBCC Code section of the North Carolina Community College System website at <http://www.nccommunitycolleges.edu/Legal/SBCCCCode.htm>. As such, individuals should not go the Administrative Code website for current State Board rules.
