11 the following provisions apply:

- 12 (a) Excess receipts shall only be used for one or more of the following purposes: instruction,
13 student support services, student financial aid (e.g. scholarships, grants, and loans), student
14 refunds, student activities, curriculum development, program improvement, professional
15 development, promotional giveaway items, instructional equipment, and capital improvements
16 and acquisition of real property.
- 17 (b) Excess receipts shall not be used for any of the following purposes: supplemental
18 compensation or benefits of any personnel, administrative costs, entertainment expenses, and
19 fundraising expenses.
