RE: Proposed Amendment of 2A SBCCC 300.6 – "North Carolina Proprietary

School Fee Schedule"

The State Board of Community Colleges has initiated the rulemaking process to amend 2A SBCCC 300.6 – "North Carolina Proprietary School Fee Schedule."

Upon the recommendation of the State Board of Proprietary Schools, the State Board of Community Colleges proposes to amend 2A SBCCC 300.6 – "North Carolina Proprietary School Fee Schedule" for the purpose of increasing license fees for initial and renewal applications by \$200. The increase is necessary to fund the adoption of an online license registration software product as well as anticipated increases in operational costs of the Office of Proprietary Schools.

The proposed amendment is published on the NC Community College System's website, www.nccommunitycolleges.edu, under "State Board Code." For your convenience, a copy of the proposed rule, with the changes indicated, is attached to this memorandum. Please post a copy of the proposed rule in prominent places so that all individuals affected by the proposed changes will be informed.

Any member of the public has the right to submit written comments on the proposed rule. Written comments on the rules must be received by no later than 5:00 p.m. on December 22, 2016. 9	Each proprietary school subject to Article 8 of Chapter 115D shall make payment as
10	directed by the SBPS according to the following fee schedule:
11	(1) Initial license - \$3,000\$3,200 plus \$50 per program submitted for licensure.
12	(2) Annual license renewal - \$1,500\\$1,700 plus \$50 per licensed program renewed; \$200
13	for each new program submitted for licensure. Any license renewal application
14	postmarked after March 15 <sup>th</sup> shall be assessed a \$500 late fee.
15	(3) Program additions submitted at any point outside of the annual license renewal period
16	- \$200.
17	(4) Program revisions - \$200.
18	(5) School relocations - \$500.
19	(6) Remote sites - \$1,000 initial site fee, plus annual renewal fee of \$750.
20	(7) Site assessments to verify statutory or SBCC Code compliance, or to approve
21	program additions or changes - \$500.
