Dr. Mark Poarch, President of North Carolina Association of Community College Presidents

President Poarch recognized his fellow president, President Rusty Hunt, and thank him for his attendance. President Poarch took a moment to congratulate Mr. Jenkins on his new employment opportunity.

President Poarch discussed the follow:

- The President's Association meeting in September at the NCACCT meeting in Wilmington.
 - Updates from myFutureNC about North Carolina's attainment goal of having two (2) million North Carolinians ages 25-44 with a post-secondary credential by 2030.
 - Economic Impact Study – stated he is looking forward to having the Economic Impact Reports, as a tool to use going into the next legislative session.
 - Stated the NCACCP approved the 3-year legislative concept and strategy.
 - Stated the State Budget is pending the budget approval to determine the numbers for the legislative request.
 - Planning to finalize legislative request to the State Board in December 2021 or January 2022.
 - Stated the Presidents Association met Wednesday in the Caswell Building with a virtual option.
 - President Poarch stated the Association had a great conversation with President and the Association heard from committees who have been very active and share a lot of information and updates.
 - President Poarch discussed a concern that was presented during the NCACCP Meeting regarding the mental health impacts of COVID and the recent suicides at the University of North Carolina at Chapel Hill. He stated anxiety, depression, and other mental health issues are "real" challenges on our campuses and continued by sharing the colleges are looking for ways to promote emotional well-being and self-care for students and employees.
 - Importance of counselors; challenges with salaries
 - The Mental Health Committee will be taking up some of these challenges.
 - President Poarch briefly provided updates on the following
 - The Personnel and Professional Development Committee
 - New President's Orientation
 - Casual Conversations
 - President's Academy with the Belk Center
 - Programs Committee, Legislative, and Finance Committees

Ms. Julie Woodson, President of North Carolina Association of Community College Trustees

- Ms. Woodson greeted Chairman Sullivan, State Board, and President Stith – stating it is great to be back at the System Office and that she is thank you to the Board for including the trustees on the State Board agenda.
- Ms. Woodson discussed the 2021 Trustees Leadership Seminar in Wilmington, sharing it was a great success. She thanked Chairman Sullivan for attending the entire seminar, stating it meant a lot to the Trustees to see him participating so actively. Ms. Woodson also acknowledged her appreciation to Ms. Ann Whitford, Ms. Lisa Estep, Sen. Sam Searcy, and Mr. Tom Looney for also being there. She stated her appreciation to President Stith and his team – including Ms. Elizabeth Grovenstein and Mr. Bill Schneider – for leading sessions on important topics such as how the community colleges are funded and how Trustees can understand Performance Measures and the right questions to ask to make sure they understand how their colleges are really doing. She shared there was also a session focused on diversity, equity and inclusion and the Adult Learners Initiative that is being supported by MyFutureNC and includes several of the community colleges already.
- Ms. Woodson shared the NCACCT meeting also had a session for Board Chairs only where President Stith spoke to the leaders of the local boards and discussed his goals for the System and emphasized the critical role they serve at their college. She shared the Board Chairs really appreciated that time to meet and have asked for additional opportunities to do that.
- She shared plans to schedule another meeting through Zoom this winter for a chance to meet again as a group the Law-Legislative Seminar next spring. Ms. Woodson shared the event will be held March 30-April 1 at the Marriott City Center, located in downtown Raleigh. She stated it will be a perfect time to discuss the collaborative legislative strategy for the systemwide priorities as we get ready for the legislative short session, which will begin in May of next year.
- Ms. Woodson took a moment to acknowledge Mr. Jenkins – who she stated rebuilt many bridges between the Associations and Board. She thanked Mr. Jenkins and stated he will be missed.
- Dr. Lyn Austin took a moment to recognize Mr. Jenkins and acknowledge his work at the College System.

Mr. Nathan Vasquez, President of North Carolina Comprehensive Community College Student Government Association

Mr. Vasquez greeted the Board and introduced himself as the new President of N4CSGA and shared a with the Board his background as a dual-enrollment student at Gaston Community College and an early college high school. He shared his intent as President and his goals to foster communication and serve as a bridge to the colleges.

- Mr. Vasquez stated since July of 2021 the Association has been working with advisors to get new members for the Executive Board of N4CSGA. He highlighted the pandemic has decreased the response rate for new members.
- Mr. Vasquez stated the Association currently has seven (7) members on Executive team with representation from South Piedmont, Forsyth Technical, Gaston, Roanoke-Chowan, and Piedmont Colleges.

- Mr. Vasquez stated during the Fall Semester N4CSGA had their first division conference, which began with a speech from Dr. Spriggs, who is the liaison of the Association. He stated the remainder of the agenda consisted of regional division meetings, student workshops led by student leadership alumni and student advisors.
- October 22-23, 2021 N4CSGA will host another virtual conference on the theme of Leading for Advocacy Creating a Movement consisting of student leadership workshops, speaker engaging dialogue. The Association will decide at this meeting whether to return to in-person meetings or continue virtually for Spring Semester.
- Mr. Vaughan welcomed Mr. Vasquez and thanked him for stepping up. He acknowledged the importance of his role as the N4CSGA President and asked him to share any needs with the Board.
- Chairman Sullivan stated his acknowledgments to Mr. Vasquez for his role.

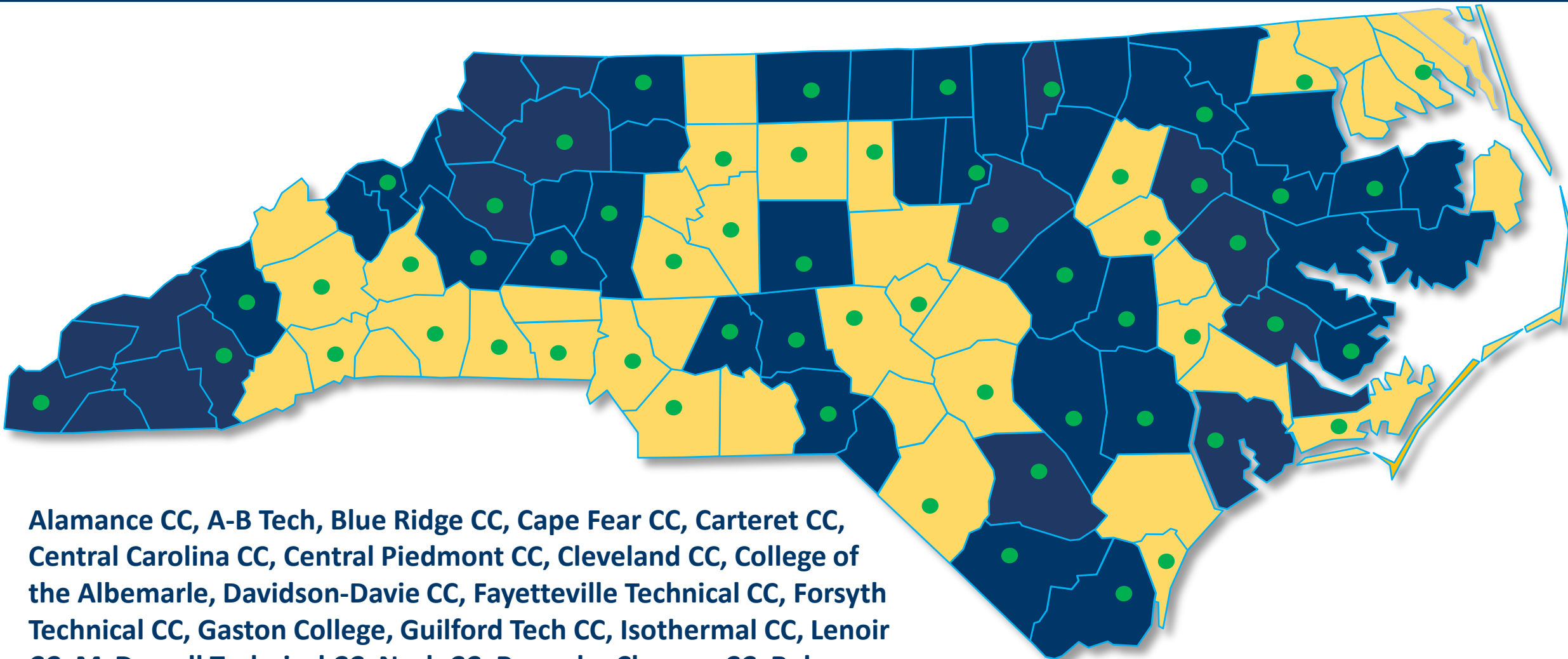


What is the REACH Collaborative?



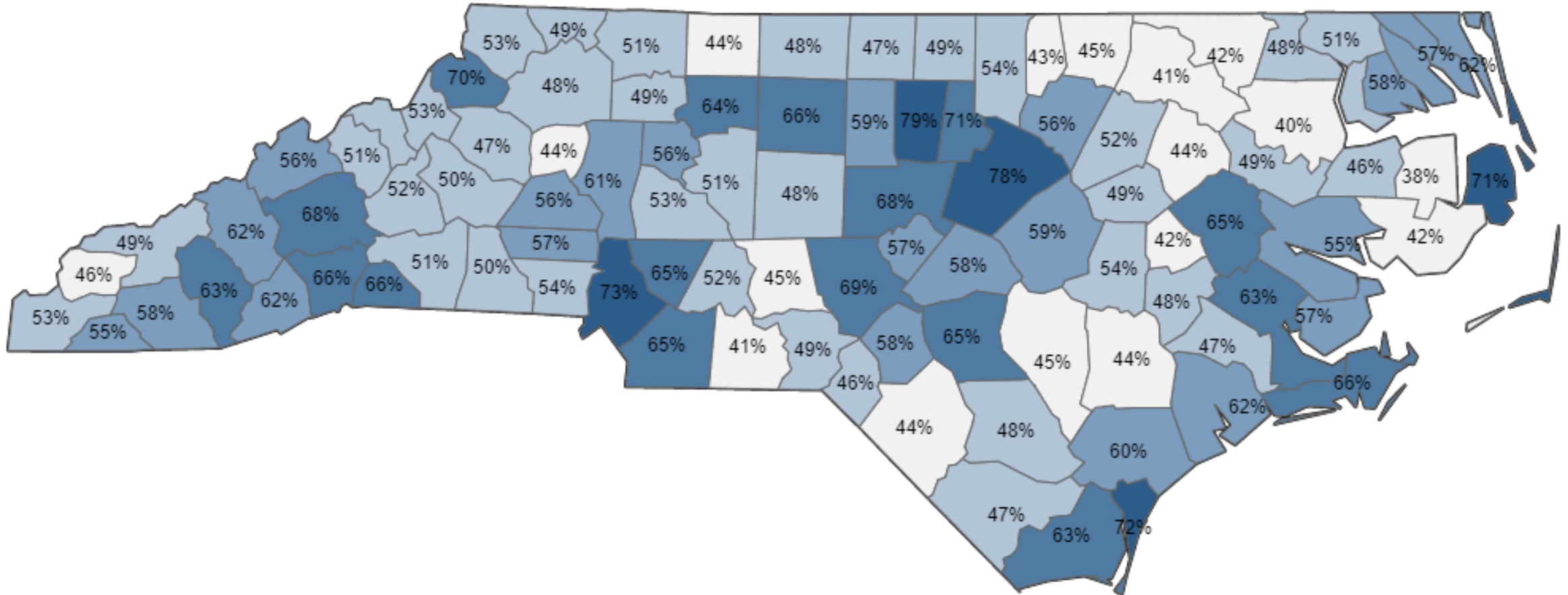
- REACH stands for Racial Equity for Adult Credentials in Higher Ed
- Project goal is a **two percent increase** in credential attainment for enrolled Black, Hispanic, and Native Americans ages 25-64 at participating colleges by 2023
- 24 NC Community Colleges are participating
- Six states (CA, CO, NC, NY, TX, VA) and 150+ community colleges are in the network
- Funded by Lumina Foundation and John M. Belk Endowment (co-investor in NC)
- Network partners include: Education Strategy Group (network management), Office of Community College Research and Leadership at the University of Illinois (equity resources for colleges), DVP-Praxis (research and evaluation), and Friday (communications and network collaboration)
- Project will run through May 2023

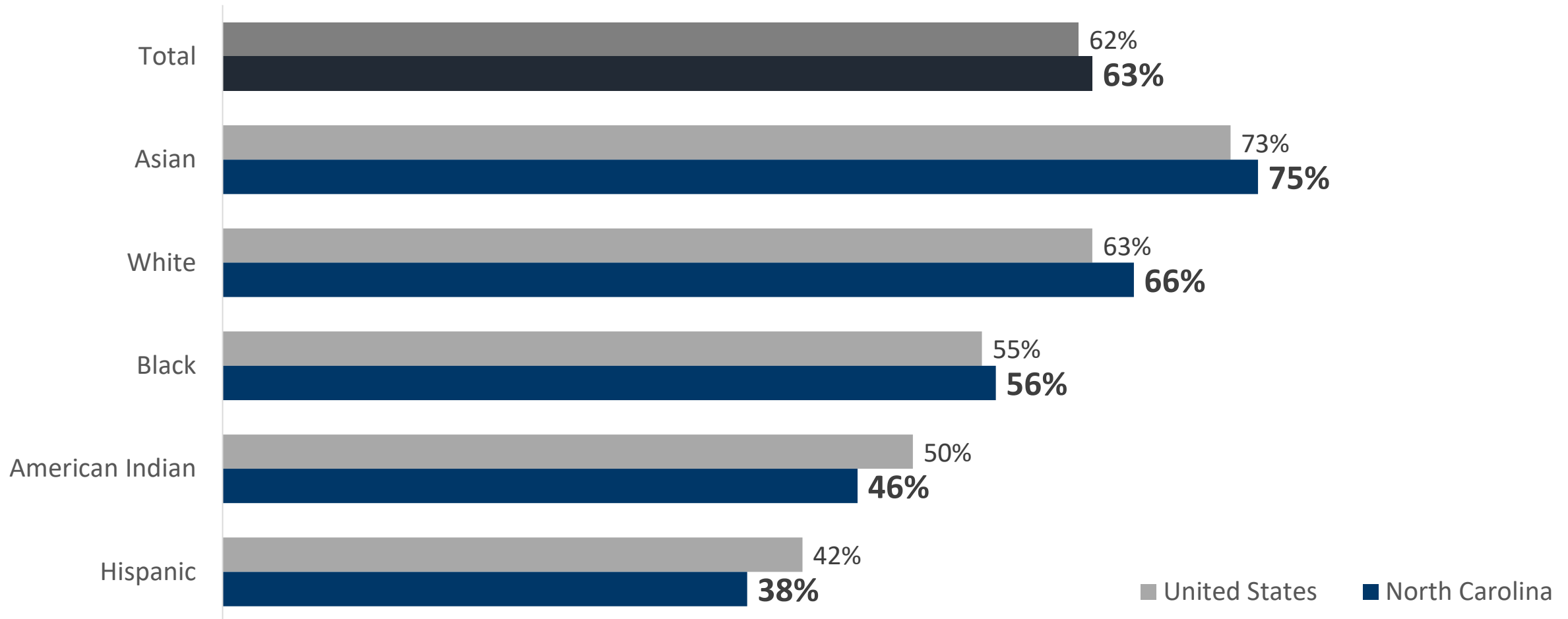

U.S. Census Bureau: Percentage of Population 25 years and over with at least some College

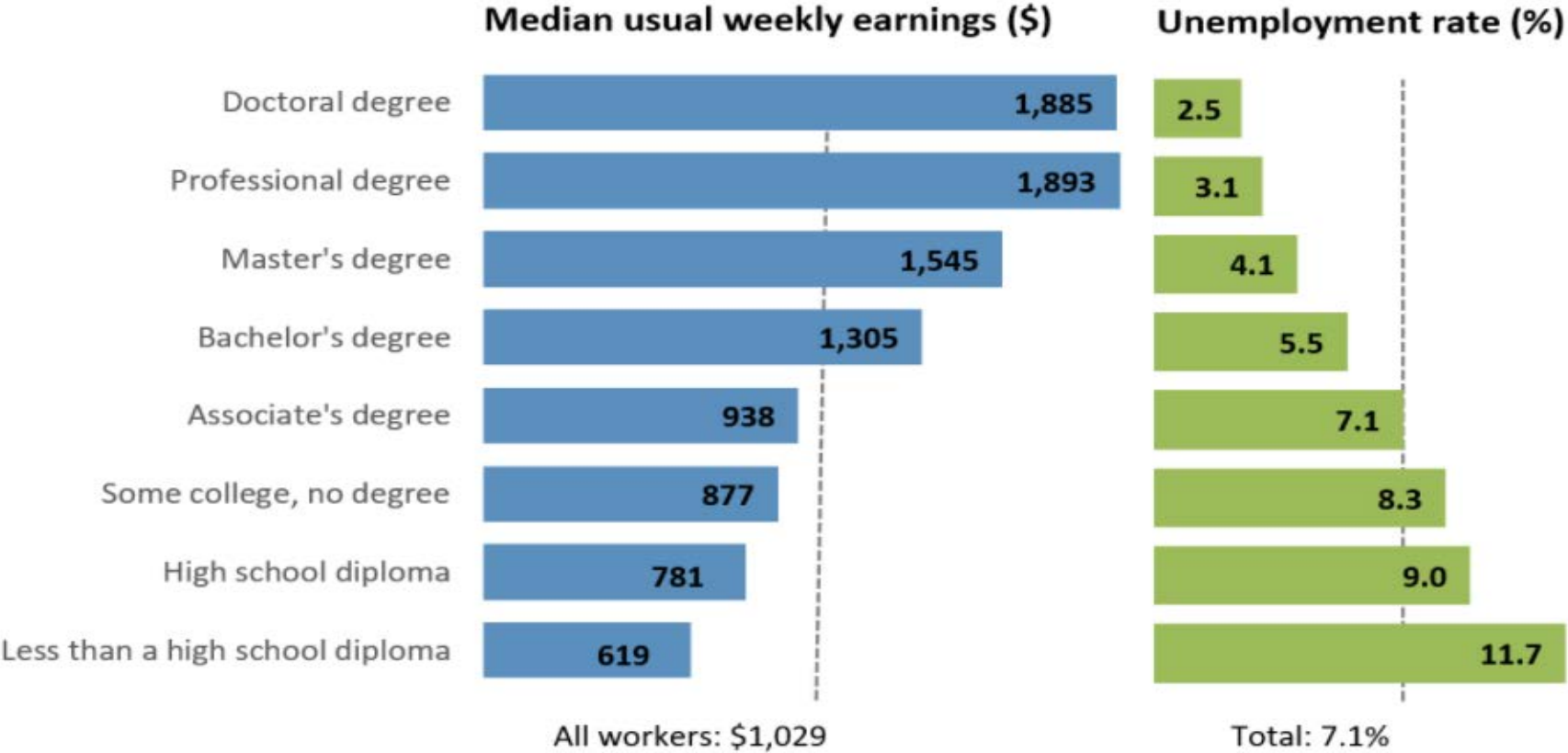
Why? Educational attainment is not equally distributed by race/ethnicity

NC REACH Collaborative Components

- 1) **Set Equity Goals** - Equity Coaches will work with colleges to review data and set strategic priorities for the project
- 2) **Identify Needs** – All colleges will conduct a needs assessment, which will inform delivery of training and supports
- 3) **Identify Pathways** - Colleges will identify four credential pathways with embedded short-term credentials leading to family-sustaining-wage jobs in their region
- 4) **Provide Training** - System Office and Student Success Center will provide trainings and professional development on providing supports tailored to the needs of adult learners of color
- 5) **Provide Supports** - System Project Team will provide mini-grants and technical assistance to colleges based on identified needs



NC Focus Area: Building Economic Equity for College & Career Readiness Students

- 70% of students in Adult Basic Skills (ABS) and English Language Learners (ELL) are student of color
- Less than 2% of Black, Hispanic or Native American students who complete 12 contact hours enroll in a postsecondary program
- We will establish a community of practice for colleges interested in implementing structured pathways for College and Career Readiness (CCR) students that accelerate credential attainment
- Additional resources from Workforce Innovation Opportunity Act (WIOA) Title II will be available to support that work

Tactic Status

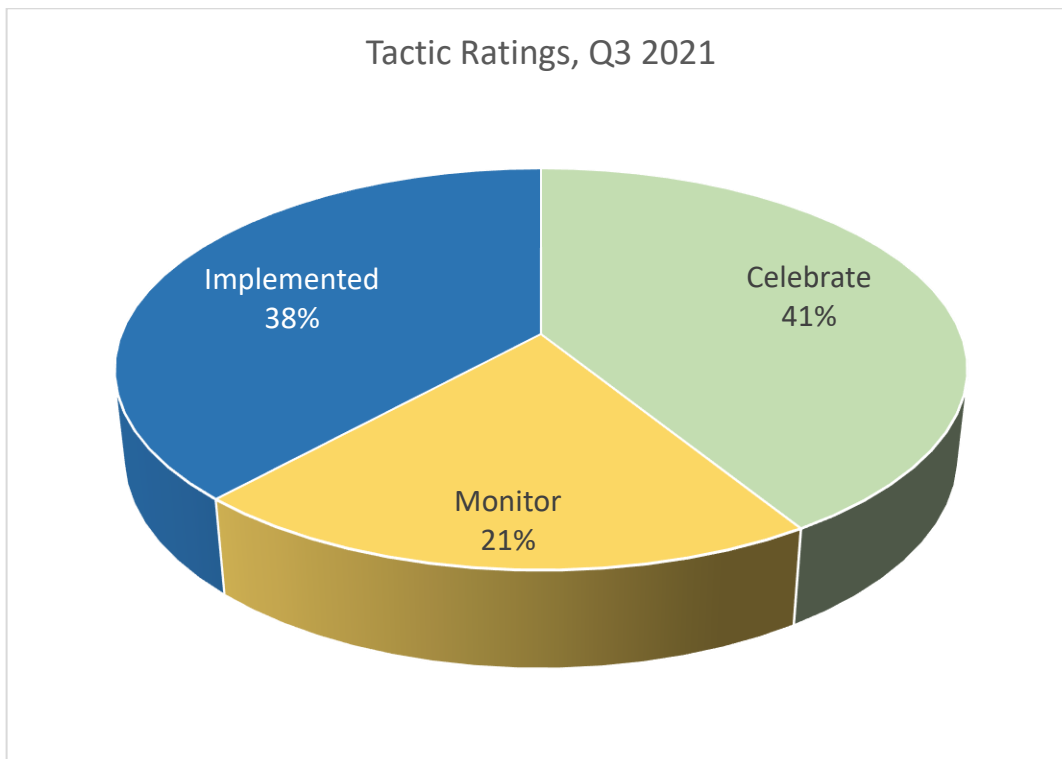
Each quarter, System Office staff that are responsible for strategic plan tactics submit quarterly updates on tactic progress, and they rate progress during the quarter in consultation with Vice Presidents. The rating categories are as follows:

- *Celebrate*: Tactic is on track and no significant obstacles exist.
- *Monitor*: Internal or external challenge(s) could impede progress toward tactic aims; senior leadership is aware and monitoring the situation.
- *Escalate*: Significant challenge(s) put the tactic at risk; senior leadership may intervene to help resolve problems.

As shown in the table above, the vast majority of tactic ratings remained the same in the third quarter of calendar year 2021 as in the second quarter. Examples of significant progress made during the July through September quarter include the following:

- **Diversity, Equity, and Inclusion** tactic: The Diversity, Equity, and Inclusion Task Force completed its work and presented its findings to the NC Association of Community College Presidents. These recommendations came before the State Board of Community Colleges at the beginning of the 4th quarter.
- **Articulation of Credits and Alignment of Pathways** tactic: President Stith and President Hans signed a Comprehensive Articulation Agreement in August to increase opportunities for community college students to transfer to public university teacher preparation programs.
- **Prior Learning Sources and Assessments** tactic (also known as Credit for Prior Learning) - The State Board voted to amend the State Board Code to strengthen the ability of students to earn credit toward curriculum programs through certain Continuing Education coursework. (Recommendations came before the State Board in September and October, and the Code change went into effect November 1.)

As shown in the pie chart and table below, seven tactics (21%) were rated as “Monitor” for the July through September 2021 quarter, 14 tactics (41%) were rated as “Celebrate,” and 13 tactics (38%) have already been implemented. No tactics were rated “Escalate” this quarter.

Pandemic Impacts

The majority of active tactics have not been impacted by the pandemic this quarter or have only been impacted in a minimal way (such as events or training occurring online).

Staff continue to monitor the Work-based Learning tactic, which is one of the tactics that has been most negatively impacted by the pandemic. In some cases, employers have pulled back from offering work-based learning experiences (through the Work-based Learning course, clinicals, and other forms of work-based learning). Activity has generally improved as the economy has more fully opened up, but some opportunities continue to be more limited.

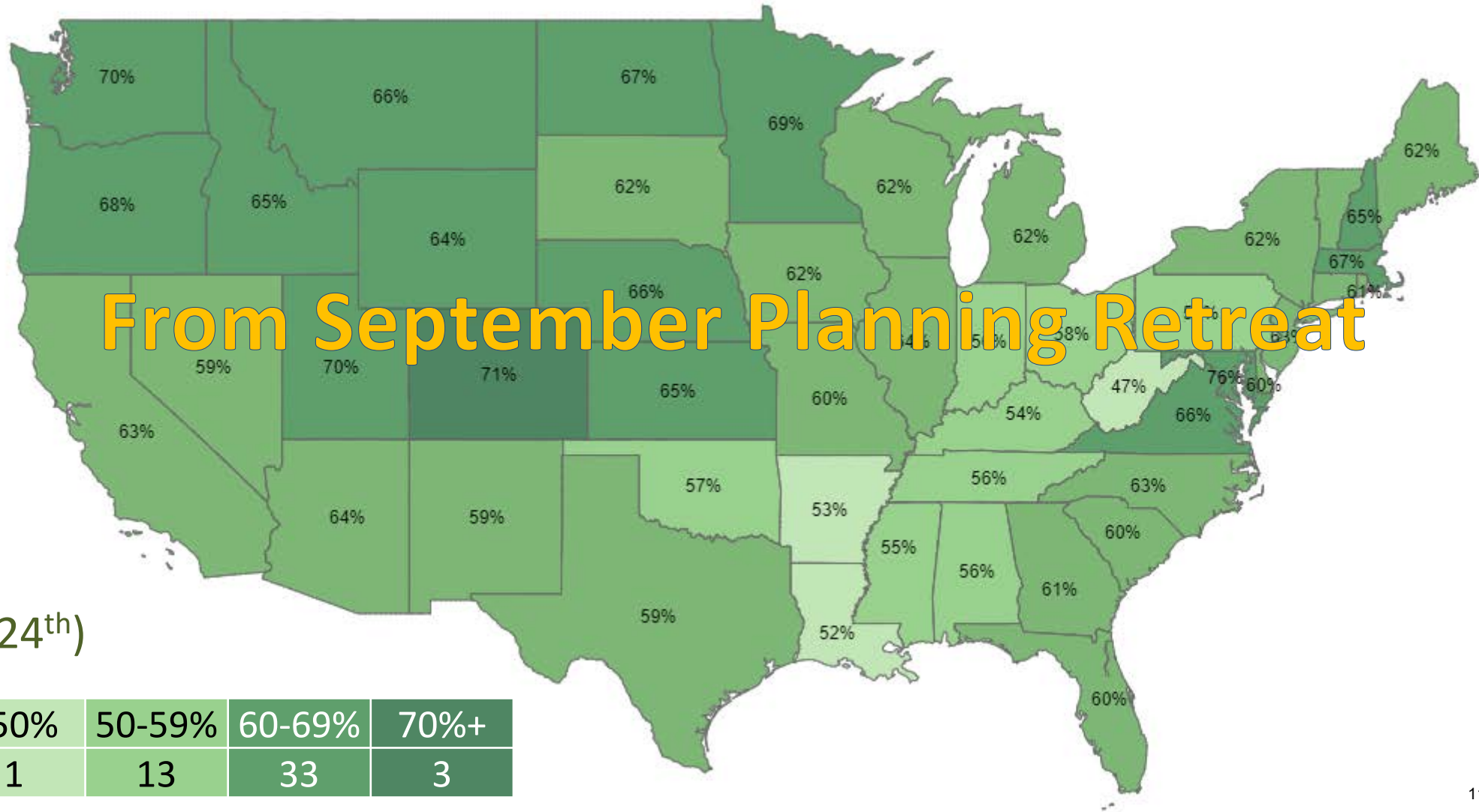
Other tactics that have been affected by the pandemic are those that rely on robust student/staff interaction or those where resources had to be reallocated for other purposes.

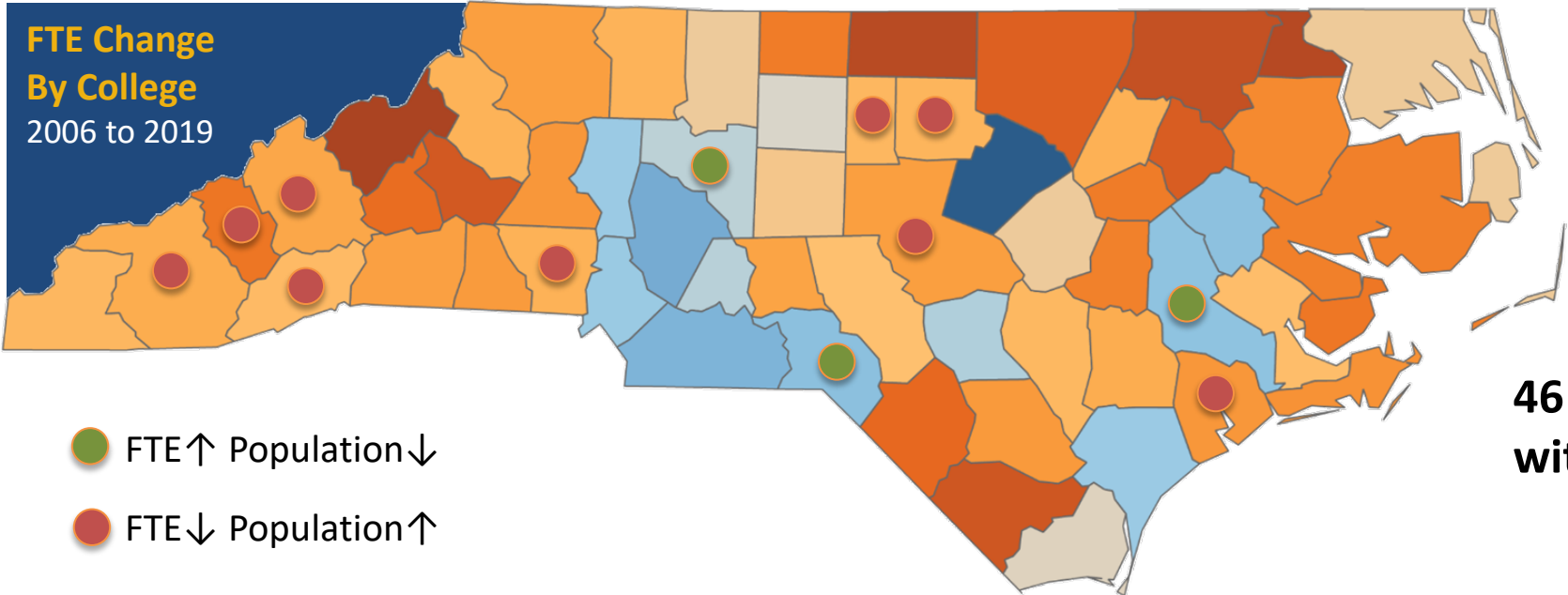
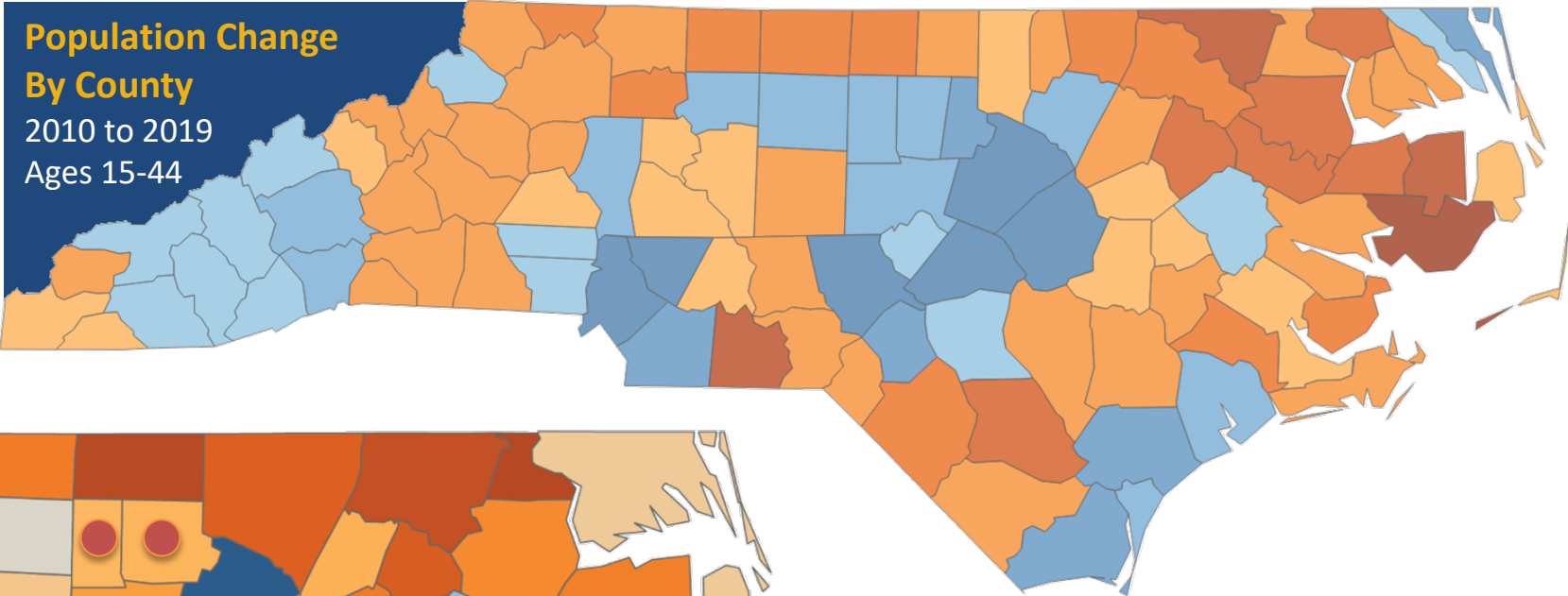


Population Change

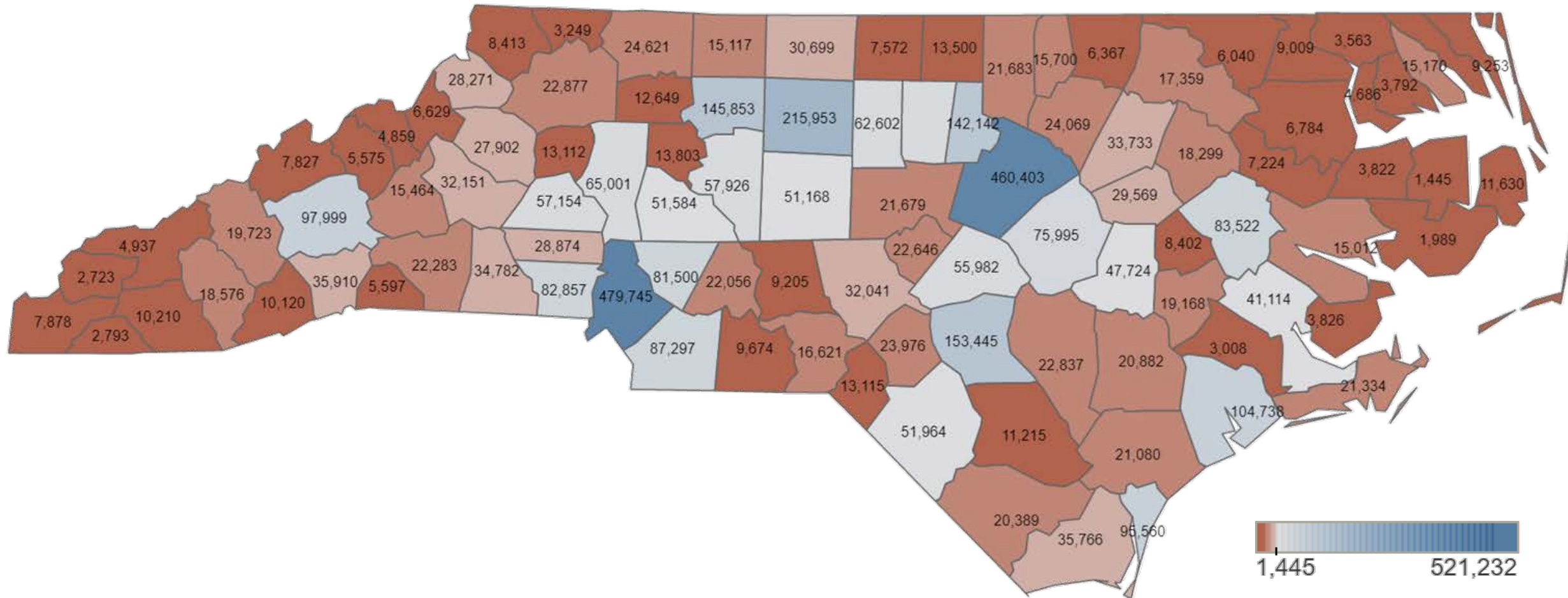

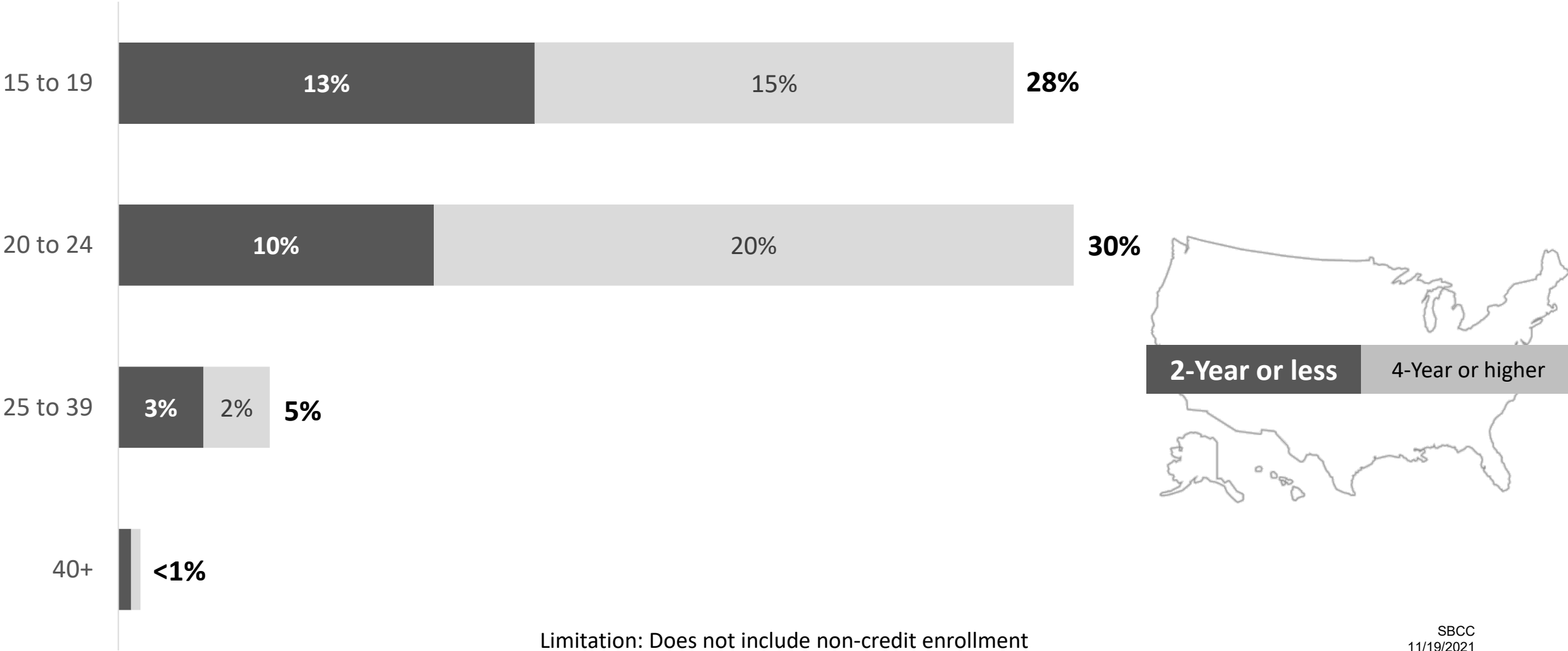

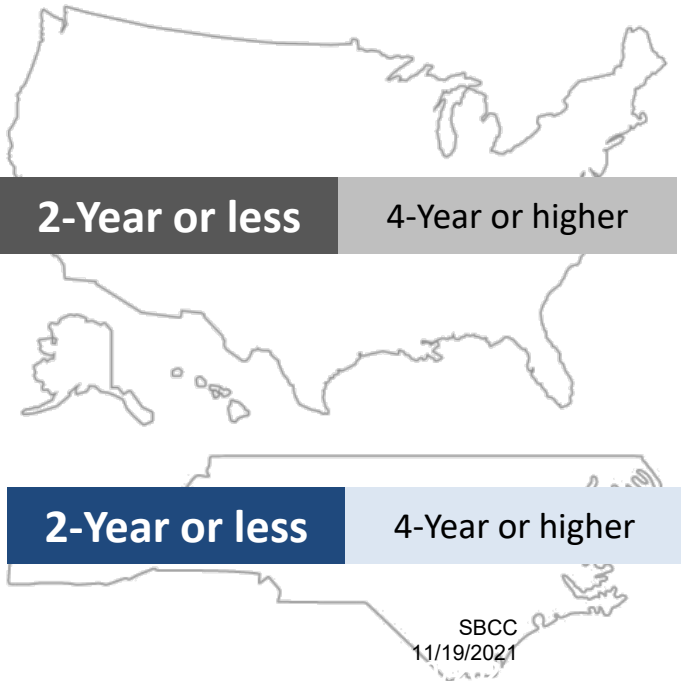
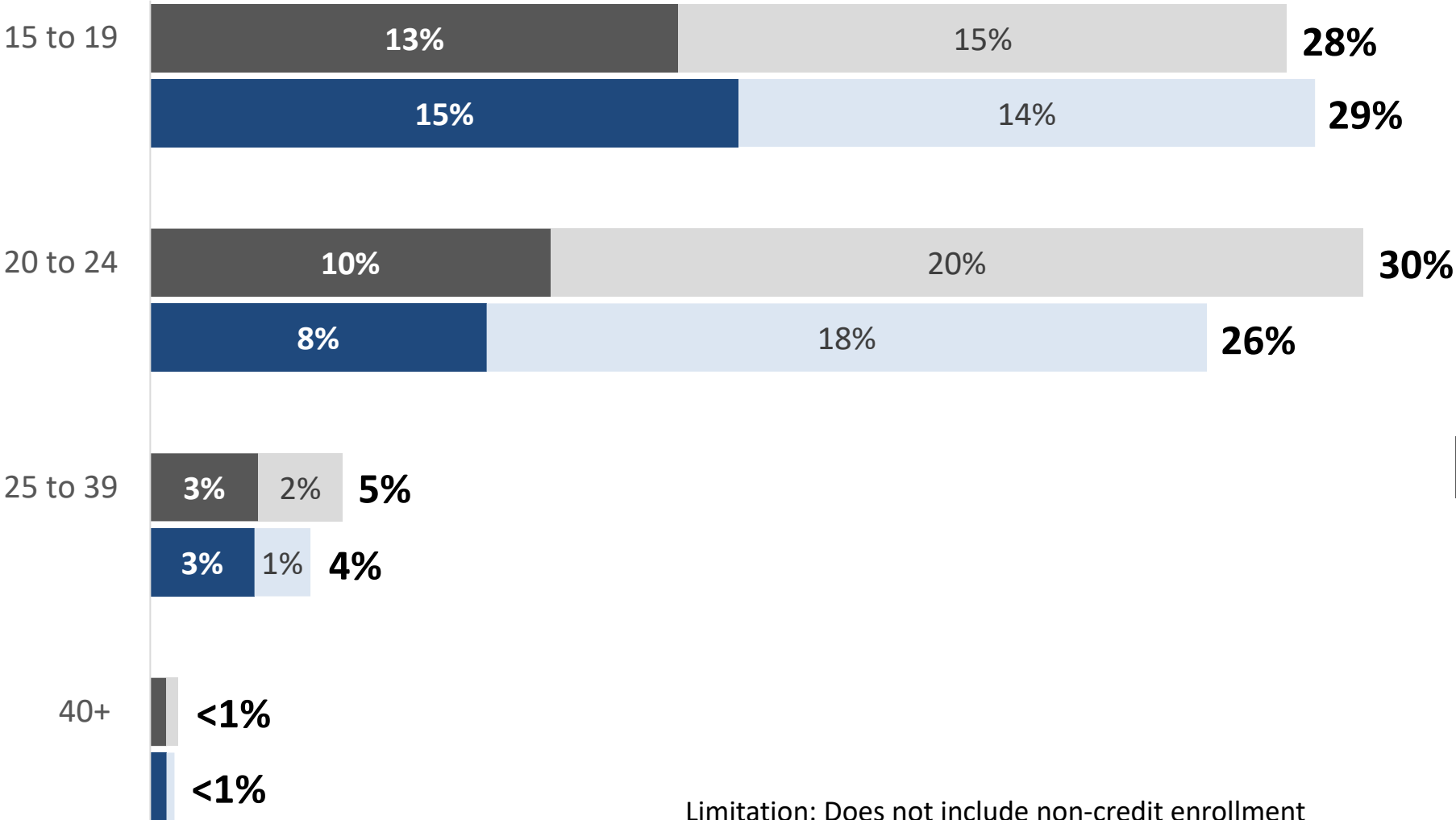
2019 Percent of Population Enrolled in Postsecondary Education By Age Range

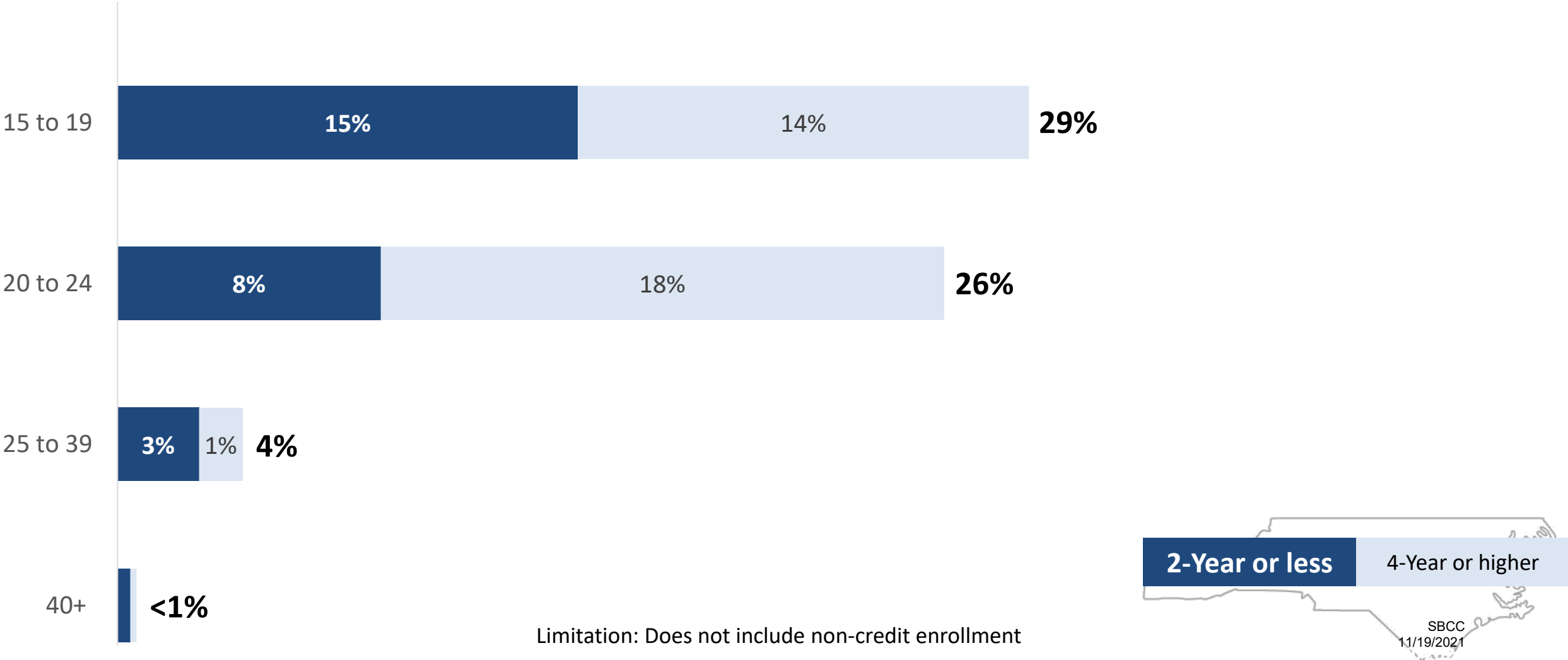

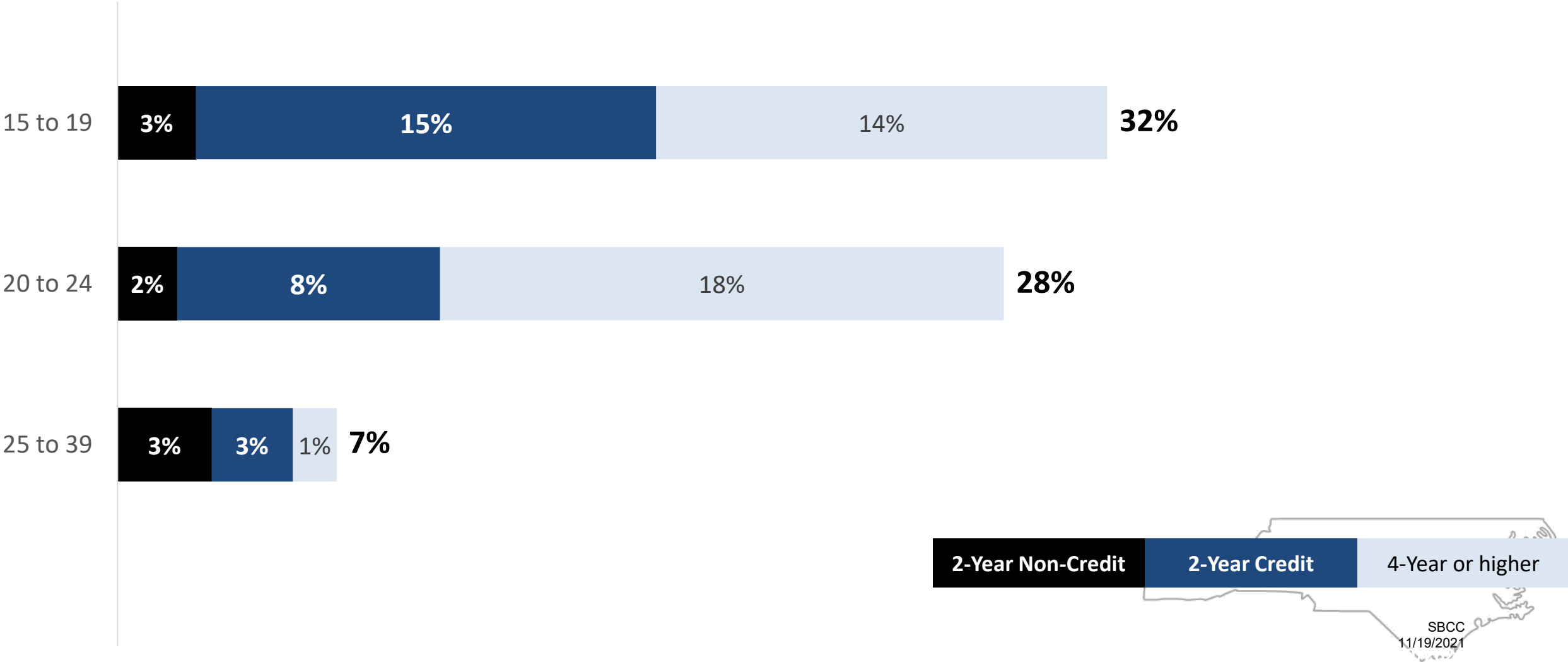


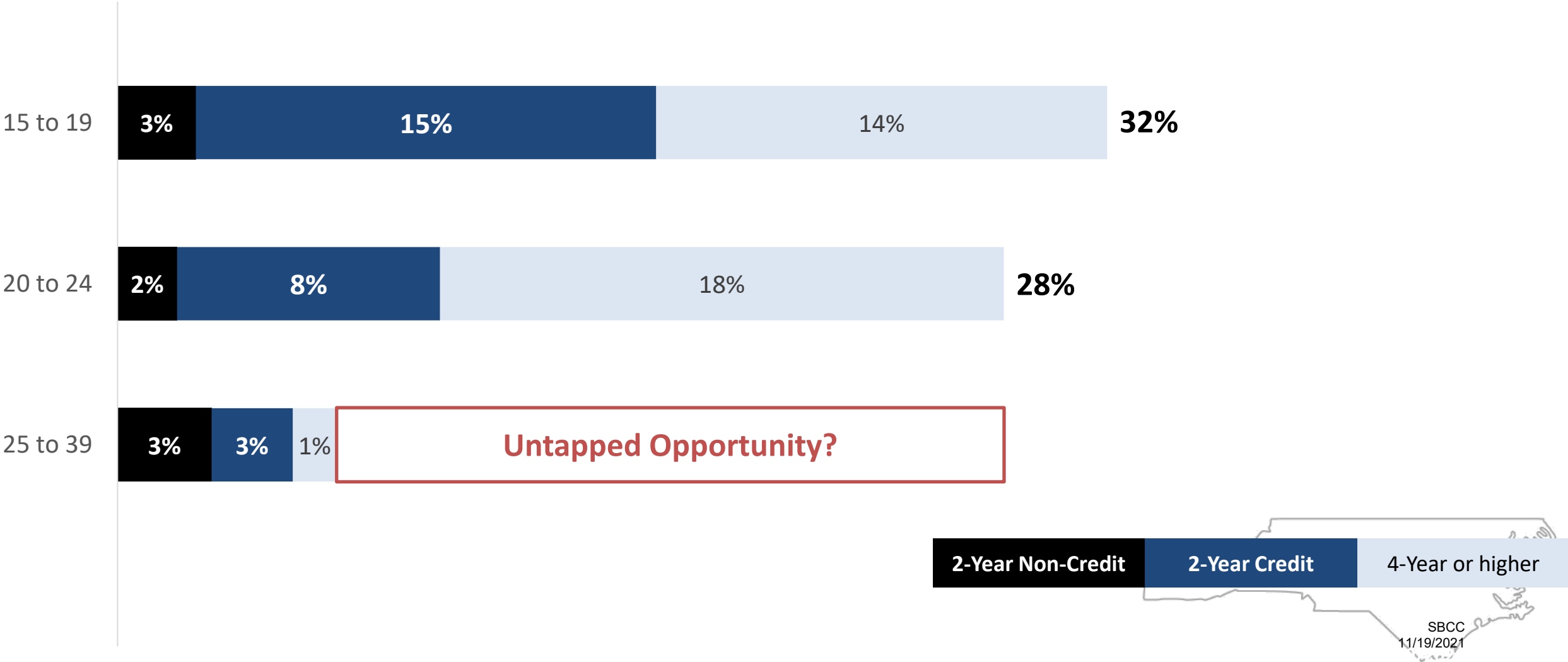
Postsecondary Enrollment Rate with Workforce CE and Basic Skills

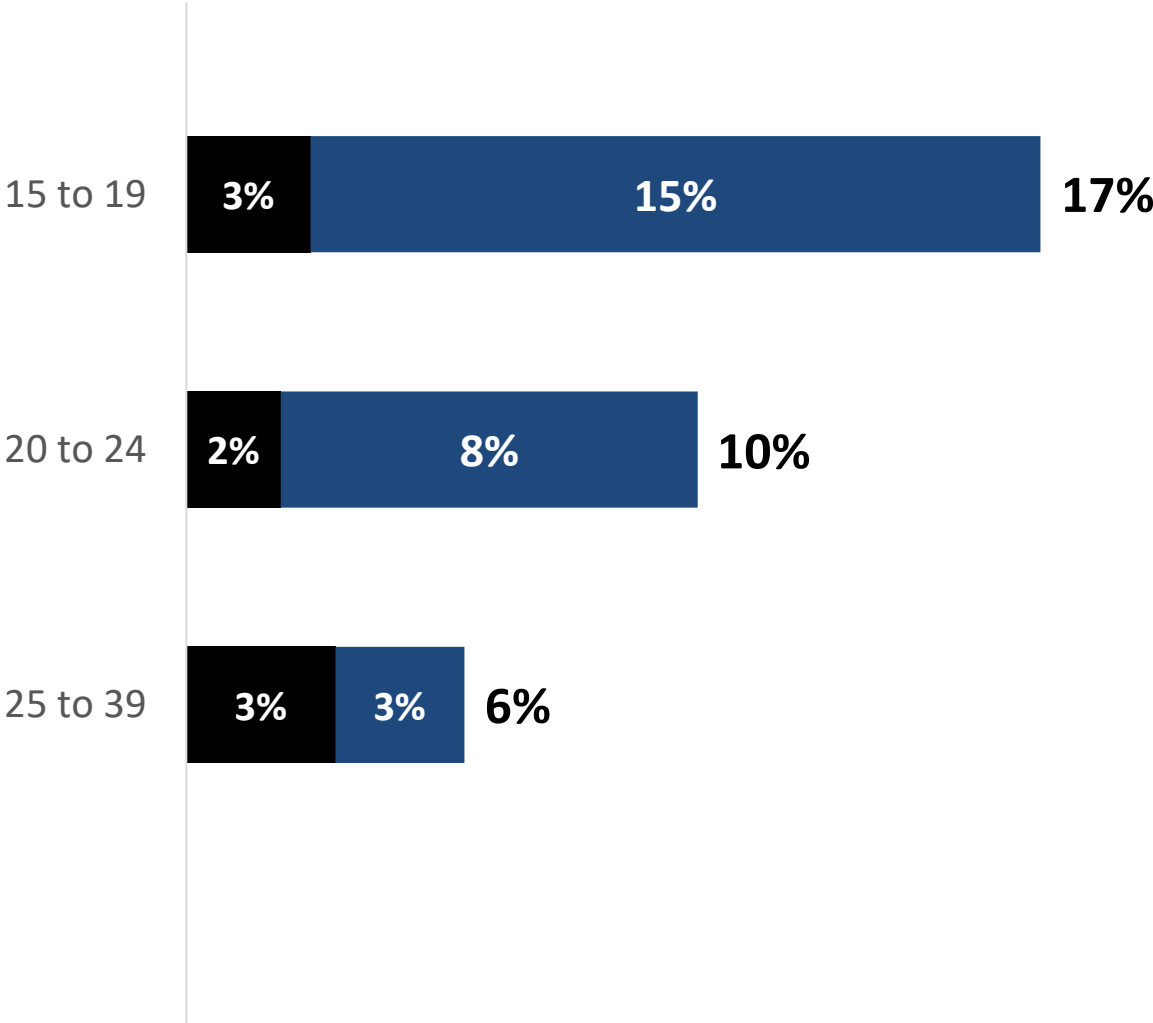

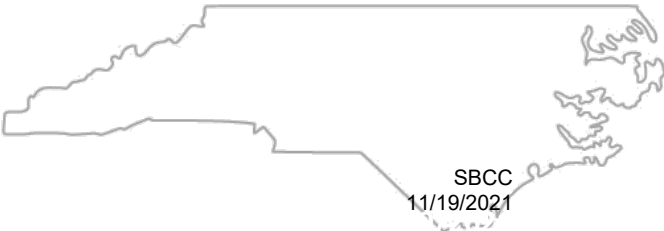
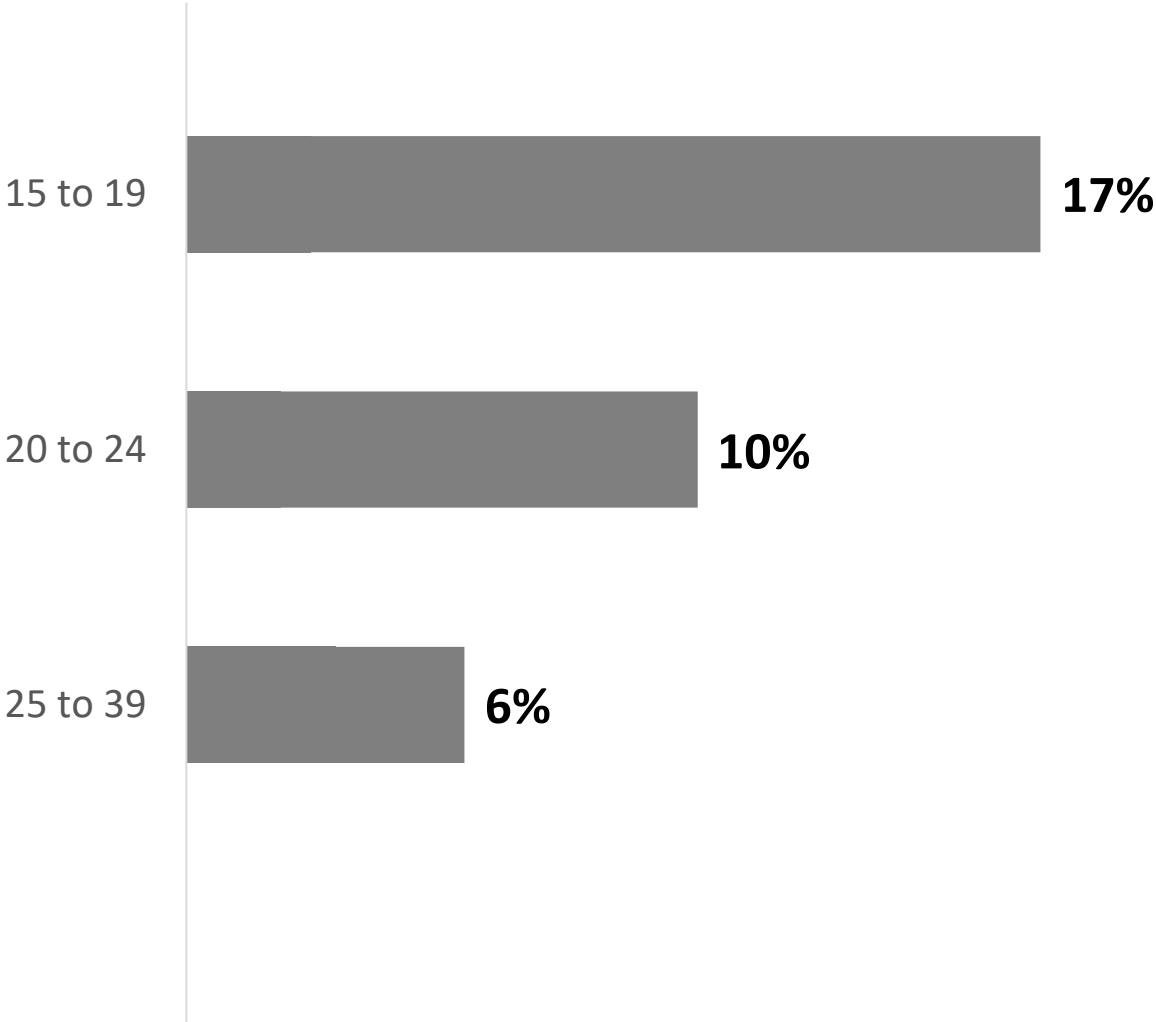




Community College Enrollment Rate

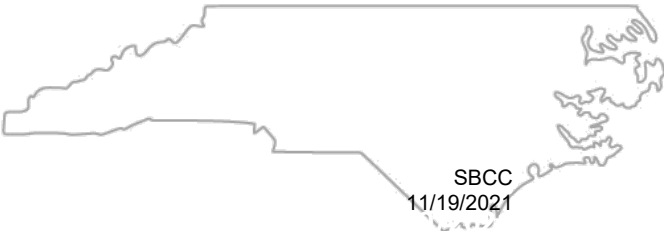
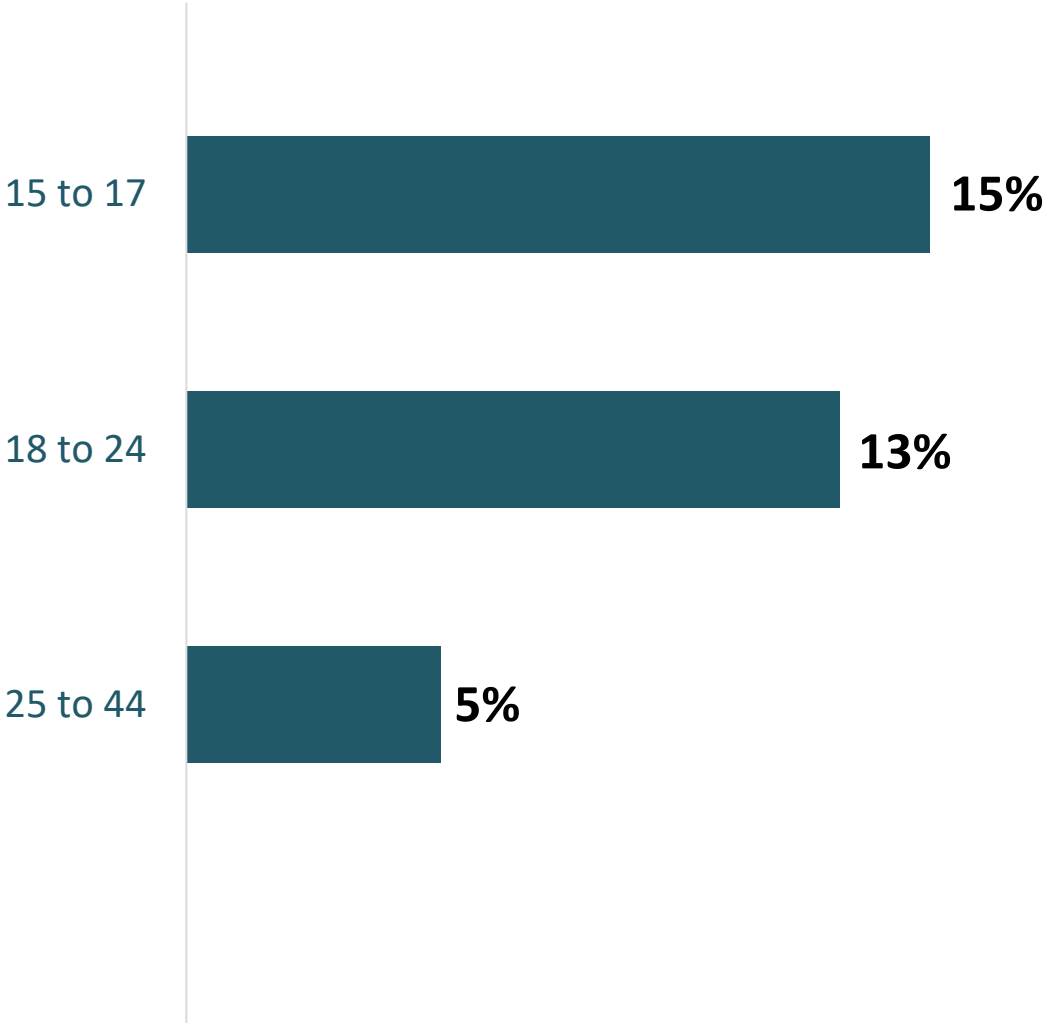

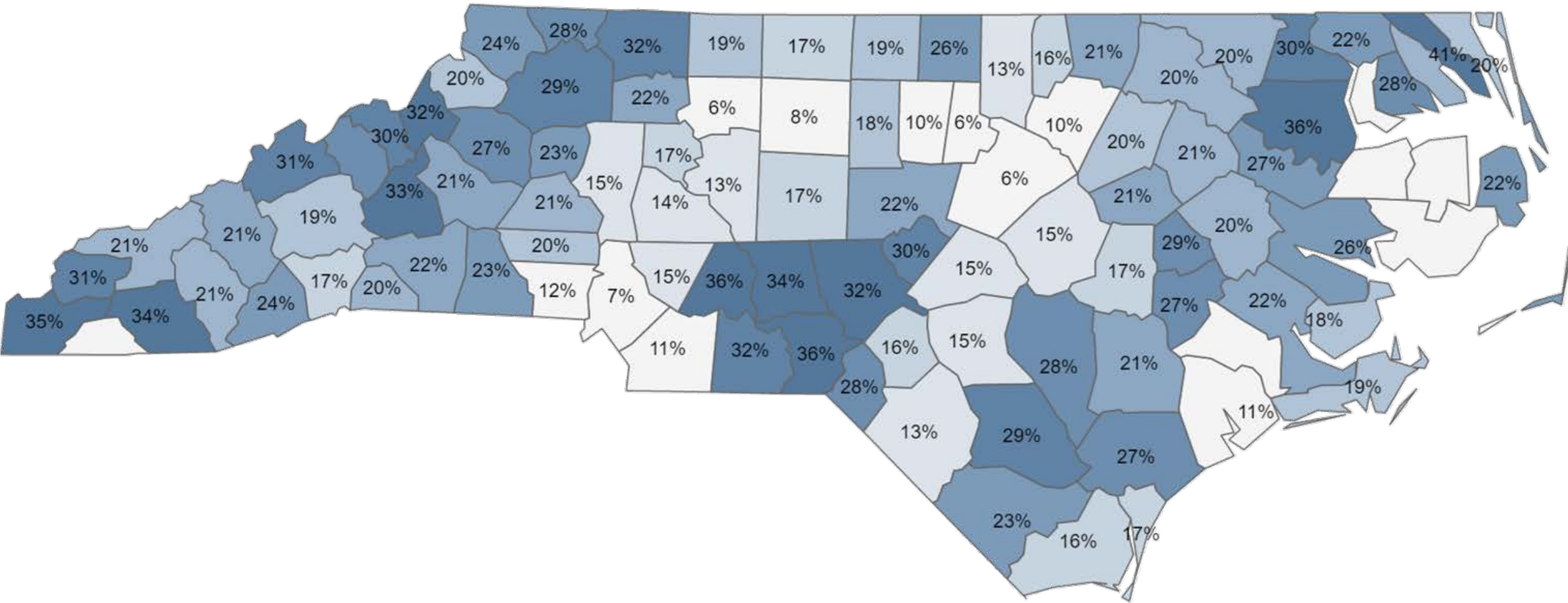
2019 Percent of NC Population Enrolled in a Community College (includes Non-Credit)

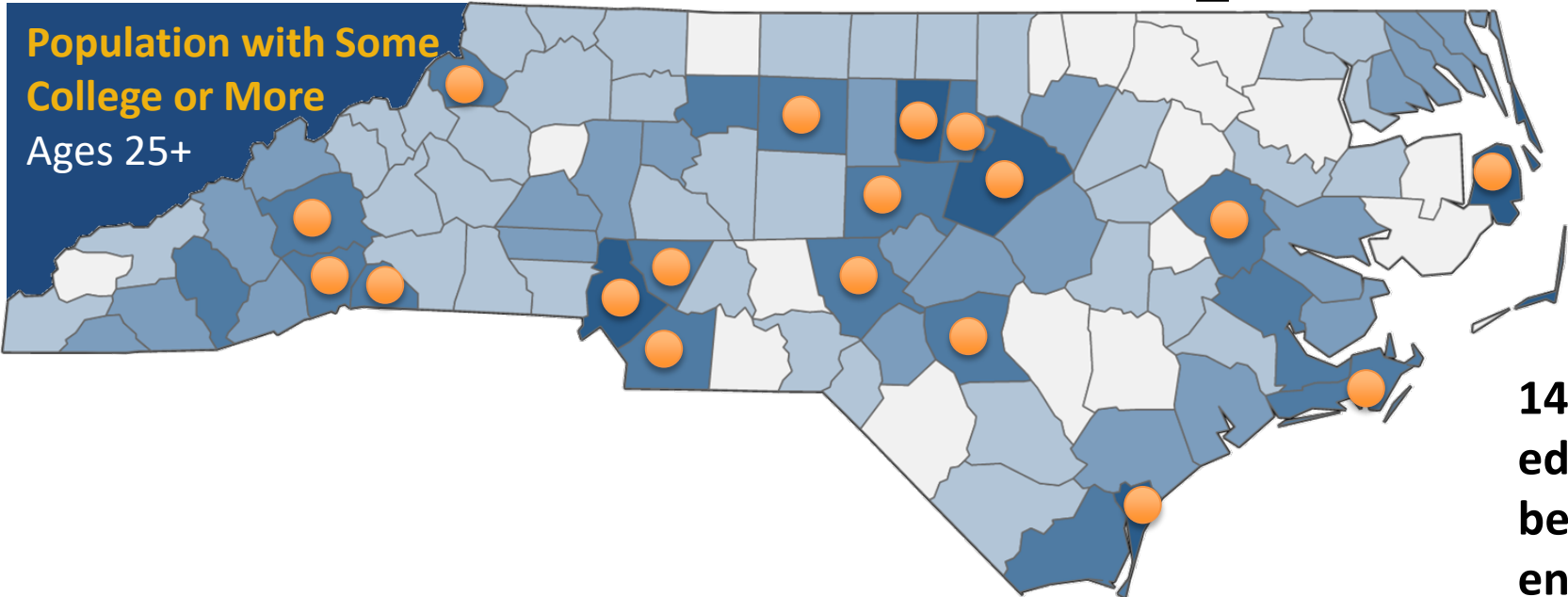

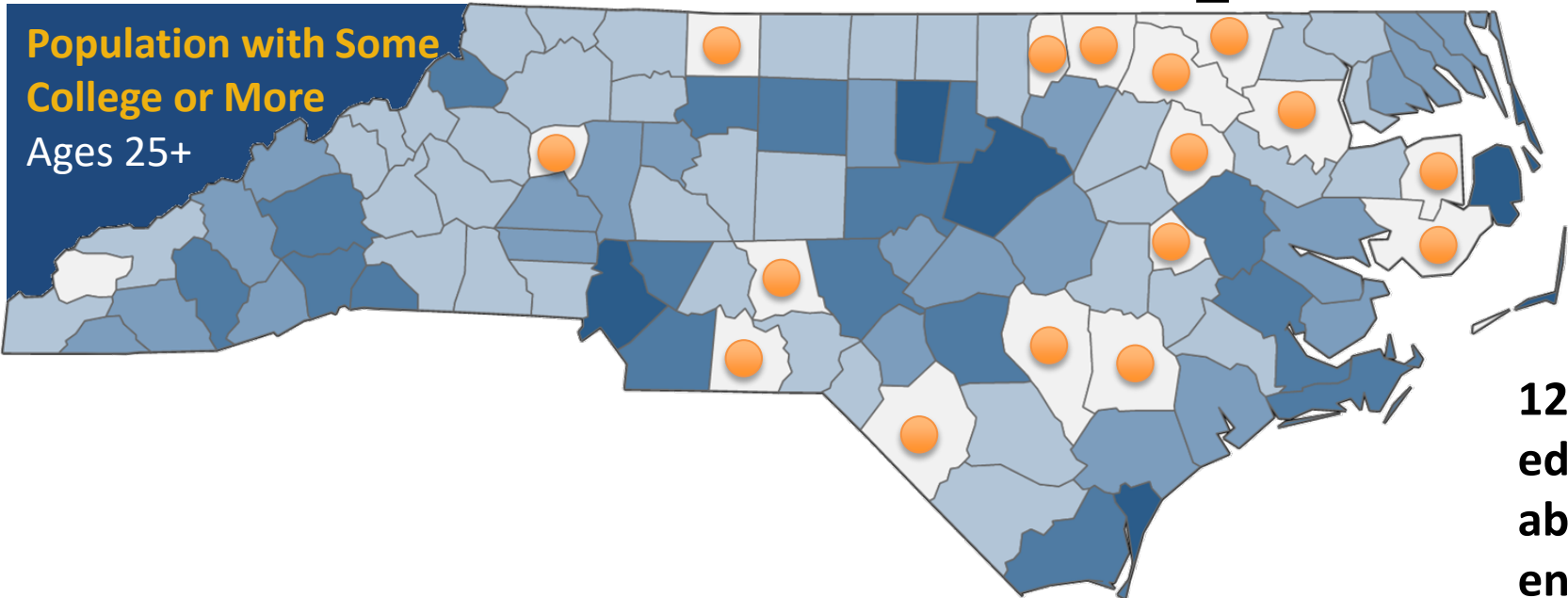

Service Agreement for Residency Determination Service (Attachment FC 02)

Ms. Grovenstein explained this service is a Legislative required service that is delivered to NCCCS, the UNC system, and independent college students who receive a state financial aid grant through the NC State Education Assistance Authority. That organization is administratively housed under the UNC System, and they were tasked with the developing this system that establishes residency of postsecondary students.

Ms. Grovenstein explained the System Office is responsible for paying for the ongoing cost and each sector of the three sectors pays the full amount towards the cost.

Ms. Grovenstein reviewed the annual and cumulative cost in the table of the item.

Mr. Penry motioned for approval; Dr. Carraway second the motion. The Committee approved Service Agreement for Residency Determination Service (Attachment FC 02).

Ms. Grovenstein explained it is a program that provides financial aid for the graduating high school students of 2021 to enroll in a community college by this fall.

Ms. Grovenstein stated the contract we established for marketing was to be able to get the word out to the 2021 high school graduating students to encourage them to enroll in a community college. Ms. Grovenstein explained it is a need-based financial aid program. Ms. Grovenstein stated we currently have data that over ten thousand high school students met the criteria and were awarded a grant. But it was determined that not all of the funding will be awarded and at least nine million in financial aid dollars are still available.

Ms. Grovenstein explained we have worked with the Governor's Office, and they have agreed that we can bring this item to you. Ms. Grovenstein stated the Governor's Office is now allowing financial aid for 2021 high school graduates to continue to be eligible if they enroll in spring 2022.

Ms. Grovenstein stated this additional funding would enable us to amend this existing marketing contract and go back out to reach additional 2021 high school graduates who did not enroll in fall to encourage them to enroll in the spring. We also expect the program to be expanded to allow 2020 high school graduates to enroll in spring and receive an award.

Purchasing Delegation Request – Johnston Community College

Request: The State Board of Community Colleges is requested to approve an increase in Johnston Community College's purchasing delegation authority to Tier 2 with a delegation authority of \$25,000.

Background: G.S. 115D-58.14(c) authorizes the State Board of Community Colleges, in consultation with the Department of Administration, "to increase or decrease the purchasing/delegation benchmark for each community college based on the college's overall capabilities, including staff resources, purchasing compliance reviews, and audit reports." 1H SBCCC 500.2 sets out the State Board's special purchasing delegation policy, including the application and evaluation processes. This policy provides for four tiers of purchasing delegation authority: (1) \$10,000, (2) \$25,000, (3) \$50,000, and (4) \$100,000.

Currently, four colleges (Central Piedmont CC, Guilford Technical CC, Pitt CC, and Wake Tech CC) have Tier 3 (\$50,000), and five colleges (Cape Fear CC, Central Carolina CC, Davidson County CC, Fayetteville Tech CC, and Vance-Granville CC) have Tier 2 (\$25,000) purchasing delegation authority; the remaining 49 colleges have Tier 1 (\$10,000) purchasing delegation authority. Johnston CC followed the noted process and requests an increase in its purchasing delegation. Its request has been reviewed and System Office staff recommends approval by the State Board. The System Office has received concurrence from the Department of Administration, Division of Purchase and Contract.

Conditions of Approval: If approved, the new delegation will be effective for two years, assuming the college does not receive a negative compliance review or demonstrate any other problems managing the increased delegation. At the end of those two years, the college may request an increase up to the next tier. The College understands and accepts the responsibilities of assuming an increase of delegation and continues to be subject to all other statutes and rules governing community college purchasing policies. A college that is granted an increase in purchasing delegation authority must agree to maintain a level of staffing, legal representation, and professional expertise that is consistent with what was represented on its increase in purchasing delegation application. If for any reason the college cannot maintain such a level, the college must notify the Procurement Services Section of the System Office.

Request: The State Board of Community Colleges is requested to approve an allocation of \$1,075,000 Title II, Adult Education and Family Literacy Act (AEFLA) funds (50% from State Leadership and 50% from Section 243, Integrated English Literacy and Civics Education) to support Phase III of the Digital Literacy Project to 43 Title II providers. The purpose of Phase III-Digital Navigator Network is to scale up the Digital Literacy Project by supplementing funds for staff resources and materials to build capacity to offer digital literacy skills training and support services. All Title II providers were invited to apply to participate in the Digital Navigator Network project. The providers listed in the table below submitted applications.

Strategic Plan Reference(s):

Theme: Student Interest and Access

GOAL: Increase the percentage of North Carolinians, particularly within underserved populations, pursuing and easily accessing education or training through North Carolina community colleges.

1. Objective 1.3: Identify and reduce access barriers for all prospective students, particularly among underserved populations.

Theme: Economic and Workforce Impact

GOAL: Increase the percentage of North Carolinians, particularly within underserved populations, pursuing and easily accessing education or training through North Carolina community colleges.

2. Objective 1.3: Identify and reduce access barriers for all prospective students, particularly among underserved populations.

Background:

College and Career Readiness Title II State Leadership Activities Strategic Focus:

To maximize Title II initiatives and funding during the 2021-22 program year, three focus areas have been identified to inform and guide Title II State Leadership Activities. These focus areas are: Build Economic Equity, Identify Opportunity, and Create Digital Transformation. The Digital Navigator Network is aligned to digital transformation and building economic equity. Research indicates that the rapid switch to digital environments for work, health, and education and other life necessities, exacerbated the historical digital skills gap problem among communities of color. Access to reliable internet connection, devices, and having the skills to navigate online

platforms are essential for participation in all areas of modern life, and these skills are essential in the COVID-19 recovery.

As we rebuild our economy, the Digital Literacy Project is a framework to ensure an equitable recovery for the adults served in our programs. In 2019-20, Title II adult education programs served over 54,000 students with over 60% from African American and Latino communities. The goal of Title II, College and Career Readiness (CCR) is to provide instruction and services to adults that lead to or facilitate transition to job training or family sustaining wage credentials. These job seekers, parents and workers need digital skills training, and support to navigate the different educational and workplace platforms to participate in regional economic recovery plans.

Rationale:

The Digital Literacy Project builds programs' capacity to improve digital inclusion in NC. This request allows the Digital Literacy Project Phase III to scale up so all programs can implement instruction and support student services with a Digital Navigator. In fall 2020-spring 2021, the NCCCS supported the Digital Literacy project with NC 2020 COVID-19 Recovery Act and Title II funds. Six adult education providers (5 colleges and 1 community-based organization) representing varying NC regions, program size and expertise in providing digital literacy instruction and distance learning options, were selected to lead this work. This work resulted in curriculum, courses and student services support needed to improve students' capacities to navigate workforce development sites and services platforms and to be prepared to navigate academic learning platforms. In Phase II, Title II funds were allocated to a cohort of 5 adult education providers to support course instruction, digital literacy project development, and digital navigator professional development and training for statewide dissemination.

The focus on Phase III - Digital Navigator Network is to create a network of trained student support staff to provide support to programs to implement the courses Transition Digital Skills (BSP 4010) and Transition Digital Skills Application (BSP 4011), and to assist students to navigate resources to transition to post-secondary programs of study or credentialed training. The lead advisor, Coastal Carolina Community College, will manage the Digital Navigator Network with training and technical assistance. Title II will provide training on the use of online curriculum.

The providers that submitted a Digital Navigator Network Application have agreed to the following requirements for participation.

Deliverables:

Digital Navigator Network Participants

1. Identify a one or more Digital Navigator.
2. Attend the Digital Navigator Training.
3. Participate in Digital Navigator Network, to include monthly meetings and reporting.

4. Develop a plan to sustain digital inclusion for students.
5. Offer a minimum of one BSP 4010 Transition Digital Skills and/or BSP 4011 Transition Digital Skills Applications courses at their campuses, community-based organizations and/or employers as a membership section.
6. Promote digital skills training as necessary for transition to post-secondary programs of study or credential attainment.
7. Manage the application of the state NorthStar license (digital literacy software used in these courses.)
8. Complete and submit to the state office via the lead consultant one quarterly and an end-of-year report reflecting the status of the Digital Navigator duties.

Funds can be used for: Salaries, both instructional and non-instructional, staff travel, educational supplies, and materials.

Funding Amount and Time Period: The \$1,075,000 request is for the period of December 1, 2021, through June 30, 2022.

Fund Source and Availability: Funding is available from the Title II Adult Education and Family Literacy Act funds (50% from State Leadership and 50% from Section 243, Integrated English Literacy and Civics Education).

Request: The State Board of Community Colleges is requested to approve an allocation of \$350,000 of Title II Adult Education and Family Literacy Act (AEFLA) State Leadership funds to expand the use of pre-apprenticeships to Apprenticeship model for increasing credential attainment for adult education students. The purpose of this funding is to support programs that were Finalists in the competitive request for proposals for the national Rethink Adult Education Challenge. Each program will be allocated \$50,000 to implement its pre-apprenticeship model between November 01, 2021, through June 30, 2022.

Strategic Plan Reference(s):

Theme: Economic and Workforce Impact

GOAL: To ensure the educational pipeline prepares a workforce possessing the interest, knowledge, skills, and abilities to meet the needs of employers, now and in the future.

- Objective 3.1: Collaborate with the stakeholders to promote a workforce system that fosters innovation and establishes seamless connections among community colleges, K-12 education, universities, workforce and economic development partners, and business and industry.

Theme: Clear and Supported Pathways for Student Progress and Success

GOAL: Provide a continuum of education, training, advising, and support to help learners make informed decisions that lead to credentials and careers.

- Objective 2.3: Increase completion of credentials for a successful transition to careers and/or further education.
 - Strategy 2.3.4: Support effective advising and coaching to help students determine, pursue, and achieve their educational and career goals.
 - Strategy 2.3.5: Promote guided educational pathways within broader career pathways.

Background: Pre-apprenticeships support adult learners by equipping people with the knowledge and skills they need to enter and succeed in apprenticeships. Pre-apprenticeship participants learn academic skills, such as math and literacy, and workplace skills, such as time management and conflict resolution. Participants also learn about their specific industries — including workplace norms and expectations or the tools and machinery they might use on the job. High-quality pre-apprenticeship programs align to industry demand, set clear pathways into apprenticeships and other industry roles, and provide support services for their participants. These programs have the potential to drive greater and more diverse participation in apprenticeships and the broader workforce.

Rationale: The U.S. Department of Education recently invited AEFLA-funded adult education providers to submit preliminary designs for pre-apprenticeship programs. Programs had to be designed to lead into an apprenticeship or similar role in an industry with high demand. The review panel selected 95 finalists to progress to Stage 2. Out of the 95, seven programs were from North Carolina. These finalists were provided access to a range of digital resources - such as case studies, activities, and webinars with subject matter experts – to help them refine their program designs. The expertise that these seven programs developed allows them to lead a pre-apprenticeship development and implementation model for Title II programs in North Carolina.

The seven finalists from North Carolina, unfortunately, were not selected as Rethink Adult Ed Challenge winners and, therefore, were not given funding from the U.S. Department of Education to implement their developed pre-apprenticeship models. These programs have expressed a need for additional funding from the System Office to operationalize the developed pre-apprenticeship models. This funding will enable these seven programs to expand workforce learning, which will allow for increased credential attainment.

Deliverables:

Providers agree to the following deliverables:

1. Implement a pre-apprenticeship program in Spring of 2022, as developed for the Rethink Adult Education Challenge.
2. Provide mid-year and end-of-year written reports via email.
3. Attend monthly check-ins to share project progression, best practices, and challenges.
4. Develop and submit a budget. Funds can be used to pay for:
 - a. Salaries of staff and faculty to develop and implement a flexible model for pre-apprenticeship,
 - b. Employment of curriculum design specialists to develop industry specific, contextualized curriculum to facilitate concurrent enrollment that equips participants with the necessary academic, occupational, and credentials needed to enter the workforce with opportunities for progression.
 - c. Development and implementation of a comprehensive outreach and recruitment campaign for pre-apprenticeships.
 - d. Student support services
 - e. Instructional software to assist in the implementation of pre-apprenticeship
5. Partnership with WIOA core partners and ApprenticeshipNC.

Evaluation of Success

These seven programs will have a compendium of best practices articles in the newsletter from the professional development team.

Programs will be evaluated on successfully operationalizing their pre-apprenticeship models.

Funding Amount and Time Period: The \$350,000 request is for the period of November 01, 2021, through June 30, 2022.

Fund Source and Availability: Funding is available from the Title II Adult Education and Family Literacy Act State Leadership funds.

STATE BOARD OF COMMUNITY COLLEGES**Summary of 2020-21 State Funded Financial Aid Programs for Community College Students**

The N.C. Community College Grant Program – Since 1991, the State Board of Community Colleges has been authorized by G.S. 115D-40.1(c) to approve disbursement of need-based financial assistance to community college students. During the 2020-21 fiscal year, 20,057 students received \$14,314,094 in Community College Grants. This represents a decrease of 2260 students and a decrease of \$5,014,429 from the \$19,328,523 disbursed during 2019-20. These grants are based upon the eligibility guidelines which are standard federal financial aid methodology. They are targeted at students who receive little or no Pell assistance and are below the Hope Scholarship Tax Credit threshold. The average award for students from this funding source was \$713.67.

Targeted Assistance – Since 2001, the State Board of Community Colleges has been authorized by G.S. 115D-40.1(b) to allocate no more than ten percent (10%) of the funds appropriated for Financial Assistance for Community College students to:

- (1) Students who do not qualify for need-based assistance but who enroll in low-enrollment programs that prepare students for high-demand occupations, and
- (2) Students with disabilities who have been referred by the Division of Vocational Rehabilitation and are enrolled in a community college.

During the 2020-21 fiscal year, colleges self-reported Targeted Assistance Funds totaling \$433,476 were awarded at 52 colleges that requested assistance for students in credit programs and non-credit programs. (Attached Spreadsheet)

Less Than Half Time – Since 2003, the State Board of Community Colleges has authorized “*The Less than Half-Time*” program which provides need-based assistance to students enrolled 6 hours or less (less than half-time) in certificate, diploma, or associate degree programs. During the 2020-21 fiscal year, colleges self-reported the Less than Half-Time Grant program provided \$75,517 in assistance to 33 colleges. (Attached Spreadsheet)

Contract for Supplemental Support of College Information System (CIS)
FY 2021-22

Request: The State Board of Community Colleges is requested to approve an amount not to exceed \$600,000 to utilize the existing managed services contract for supplemental support with the North Carolina customizations of the College Information System (CIS) template.

Strategic Plan Reference(s):

Theme: System Effectiveness

Goal 4: To advance organizational effectiveness, operations, and decision-making in order to support a cohesive system of nimble, empowered and community-driven colleges.

- Objective 4.1: Ensure that colleges within the System have access to technology and related infrastructure in order to meet student and institutional needs.

Background: The CIS is, and has been since its inception, based on the Ellucian Colleague® application with customizations to support North Carolina specific reporting requirements. The CIS maintains the student record and other faculty, staff, and institutional information at our 58 community colleges. Since late October 2021, the System Office has received four key staff members' notice of separation. Three of the four staff members are critical to supporting these North Carolina customizations. Ellucian provides updates to Colleague several times a year, and the customizations must be incorporated in each release prior to being used by the colleges.

A Managed Services Contract was established to provide comprehensive expertise in the areas of CIS administration of the Ellucian Colleague application, database, underlying database application services, operating systems, and security support for the CIS through selected vendors. Ferrilli and CampusWorks, Inc. currently are the selected vendors for this contract. On July 16, 2021, the SBCC approved "Contract for Migration and Support of College Information System (CIS) in the Cloud" to expedite Cloud migrations.

Rationale: The System Office wants to utilize the Managed Services Contract to provide the necessary knowledge, skills and ability while the System Office recruits new permanent staff. The contractors will incorporate the North Carolina customizations for each release of Colleague, to then be made available to the colleges while the positions are transitioned to the new hires. This support will ensure that colleges receive necessary updates for Colleague and assist with the transition for new staff.

Method of Procurement: In accordance with the procurement practices of the State of North Carolina, approval for the Managed Services Contract, as an Agency Specific Contract, was awarded by the NC Department of Information Technology. Approval for the services provided by Ferrilli is contingent upon State Board approval.

Contract Amount and Time Period: The service period is from December 1, 2021, through June 30, 2023, for an amount not to exceed \$600,000.

Fund Source and Availability: Funding is available from the IT project budget code 26802, which is used for upgrading the existing CIS.

CHAPTER D. EDUCATIONAL PROGRAMS

SUBCHAPTER 800. CREDIT FOR PRIOR LEARNING

1D SBCCC 800.2 General Provisions

- (a) The purpose of this Subchapter is to guarantee that all North Carolina Community Colleges follow consistent academic conventions to ensure the integrity of the CPL process and to establish minimum standards for all NC community colleges.
- (b) Consistent with the provisions of this Subchapter colleges are authorized to award CPL using the following prior learning methods:
- (1) Apprenticeship
 - (2) State or Industry Recognized Credentials/Continuing Education to Curriculum Credit
 - (3) Courses listed in high school to community college articulation agreements.
 - (4) Military education and training
 - (5) Standardized examinations
 - (6) Challenge exams/Proficiency
 - (7) Portfolio assessment
 - (8) Public Safety Training (PST) prefix courses
- (c) Colleges may award curriculum CPL when the documentation of prior learning meets or exceeds a demonstration of learning outcomes at the institutions' standards for awarding credit for the corresponding curriculum course. Institutions may award CPL that exceeds the minimum standards established in this Subchapter.
- (d) Colleges may only award curriculum CPL that is directly applicable to a student's declared curriculum program of study.
- (e) CPL for advanced courses does not negate the requirement to meet requisite learning outcomes.

- (f) CPL may be used to fulfill program requirements except for mandatory institutional requirements. Examples may include, but are not limited to, requirements of external agencies that specifically prohibited the use of CPL to fulfill the program requirements.
- (g) CPL cannot be used to satisfy the college's institutional credit requirements, which prescribes the minimum percentage of credit hours a student must earn through instruction offered by the institution awarding the credential. No greater than seventy-five percent (75%) of the credit hours required for graduation from a curriculum program of study may be earned through CPL.
- (h) Any CPL awarded by a college shall be reflected in the student's records by the college's Registrar Office without quality points assigned, except for allowances for graded military credit as described in 1D SBCCC 800.6"
- (i) Course Credit CPL standards approved by the CCRC shall be considered for transfer to any college in the North Carolina Community College System.
- (j) The local board of trustees shall adopt a policy governing the awarding of CPL. At a minimum, the local policy shall be consistent with standards established by this Subchapter. The local policy may include additional opportunities for students to receive CPL. Each college shall publish its CPL policy in the college's educational catalog.
- (k) Colleges shall establish a procedure that students must follow to request a prior learning assessment. This procedure shall be published in the college's educational catalog.
- (l) To be eligible to receive CPL, students must meet all of the following criteria:
- (1) Meet all admission requirements for their program of study.
 - (2) Be enrolled in a curriculum program to which the credit will directly apply; and
 - (3) Request a prior learning assessment consistent with the college's CPL procedures and provide all documentation by the published deadlines.
- (m) Nothing in this rule shall be construed to supersede limitations imposed by an accreditation, credentialing, licensure, or other external agency on the application of CPL towards credentials under their purview. In such instances, the college shall document the applicable limitations in the student's file.

- 1 (n) It is possible that CPL from (b)(1), (b)(2), (b)(3), (b)(6), (b)(7), or (b)(8) may not be
2 transferable to UNC System constituent institutions. Furthermore, UNC System
3 SBCC institutions may request documentation to determine potential course credit.
4 Colleges should encourage students to consult a UNC System transfer advisor
5 before using these CPL sources to attain credit at a community college institution.

CHAPTER D. EDUCATIONAL PROGRAMS

SUBCHAPTER 400. CURRICULUM PROGRAM OF STUDY

1D SBCCC 400.10 Curriculum Program of Study

- (a) Each curriculum program shall be designed based on criteria established by the curriculum standard for the individual program.
- (b) In all programs, colleges shall comply with the Southern Association of Colleges and Schools Commission on Colleges' general education requirements and the general education areas identified by the State Board of Community Colleges.
- (c) The initial and revised program of study shall be filed with and approved by the North Carolina Community College System Office prior to implementation. If a curriculum standard is revised, a revised program of study shall be submitted and approved by the North Carolina Community College System Office within one year following the effective term, unless immediate implementaton is required by the State Board of Community Colleges.
- (d) The associate in general education and general occupational technology programs shall be comprised of courses from the college's other approved programs of study. Colleges are not required to file programs of study for the associate in general education or general occupational technology programs with the North Carolina Community College System Office for review or approval.
- (e) The following components shall be included in the development of a curriculum program of study:
- (1) Semester Hour Credits Required: The total semester hours of credit required are as follows:
- (A) Certificate: A certificate program which is a stand-alone curriculum program title or which is the highest credential level awarded under an approved associate in applied science degree or diploma program shall include a minimum of twelve semester hours of credit from core courses as defined in 1D SBCCC 400.10(e)(3)(A) and as indicated on the curriculum standard as

defined in 1D SBCCC 400.9. The certificate program shall consist of a minimum of twelve and a maximum of eighteen semester hours of credit from curriculum courses at the 100-299 level.

(B) Diploma: A diploma program which is a stand-alone curriculum program title or which is the highest credential level awarded under an approved associate in applied science degree shall include a minimum of twelve semester hours of credit from core courses as defined in 1D SBCCC 400.10(e)(3)(A) as indicated on the curriculum standard as defined in 1D SBCCC 400.9. The diploma program shall consist of a minimum of thirty-six and a maximum of forty-eight semester hours of credit from curriculum courses at the 100-299 level.

(C) Associate in Applied Science: The associate in applied science program shall consist of a minimum of sixty-four and a maximum of seventy-six semester hours of credit from curriculum courses at the 110-199 and 210-299 levels. Within the Associate in Applied Science program the college shall include opportunities for the achievement of competence in reading, writing, oral communication, fundamental mathematical skills, and basic use of computers.

(D) Associate in Arts, Science, and Engineering: The associate in arts, science, and engineering programs shall consist of a minimum of sixty and a maximum of sixty-one semester hours of credit from approved college transfer curriculum courses at the 110-199 and 210-299 levels. Within the Associate in Arts, Science, and Engineering program, the college shall include opportunities for the achievement of competence in reading, writing, oral communication, fundamental mathematical skills, and basic use of computers.

(E) Associate in Fine Arts in Music, Visual Arts and Theatre: The associate in fine arts in music, visual arts, and theatre programs shall consist of a minimum of sixty and a maximum of sixty-one semester hours of credit from approved college transfer curriculum courses at the 110-199 and 210-299 levels. Within the associate in fine arts in music, visual arts, and theatre programs, the college shall include opportunities for the achievement of competence in reading, writing, oral communication, fundamental mathematical skills, and basic use of computers.

(F) Associate in General Education: The associate in general education program

shall consist of a minimum of sixty-four and a maximum of sixty-five semester hours of credits from curriculum courses at the 110-199 and 210-299 levels and that are comprised of courses from the college's other approved programs of study. Within the associate in general education program, the college shall include opportunities for the achievement of competence in reading, writing, oral communication, fundamental mathematical skills, and basic use of computers.

(G) Associate in General Education Nursing: The associate in general education nursing program shall consist of a minimum of sixty and a maximum of sixty-one semester hours of credits from curriculum courses at the 110-199 and 210-299 levels. Within the associate in general education nursing program, the college shall include opportunities for the achievement of competence in reading, writing, oral communication, fundamental mathematical skills, and basic use of computers.

(2) General Education: The general education hours required are as follows:

(A) Certificate: General education is optional in certificate curricula.

(B) Diploma: A diploma program shall include a minimum of six semester hours of credit from general education curriculum courses selected from the Combined Course Library, including:

(i) a minimum of three semester hours in communications; and

(ii) a minimum of three semester hours in humanities/fine arts, social/behavioral sciences, natural sciences or mathematics.

(C) Associate in Applied Science and Associate in General Education: An associate in applied science and an associate in general education program shall include a minimum of 15 semester hours of credit from general education curriculum courses selected from the Combined Course Library, including:

(i) a minimum of six hours in communications. ENG 111 shall be utilized for three of these hours. ENG 110 may be utilized as a substitute for ENG 111 if included in the approved program of study;

(ii) a minimum of three hours in humanities/fine arts;

(iii) a minimum of three hours in social/behavioral sciences; and

(iv) a minimum of three hours in either natural sciences or mathematics.

(D) Associate in Arts: An associate in arts program shall include a minimum of 45 semester hours of credit from courses classified as general education within the Comprehensive Articulation Agreement from the Combined Course Library, including:

(i) 31-32 semester hours of credit from universal general education transfer component courses that shall include the following:

(I) six semester hours of English composition;

(II) nine semester hours of communications and/or humanities/fine arts;

(III) nine semester hours of social/behavioral science;

(IV) three to four semester hours of mathematics; and

(V) four semester hours of natural sciences.

(ii) An additional 13-14 semester hours of credit from courses classified as general education within the Comprehensive Articulation Agreements.

(E) Associate in Science: An associate in science program shall include a minimum of 45 semester hours of credit from courses classified as general education within the Comprehensive Articulation Agreement from the Combined Course Library, including:

(i) 34 semester hours of credit from universal general education transfer component courses that shall include the following:

(I) six semester hours of English composition;

(II) six semester hours of communications or humanities/fine arts;

(III) six semester hours of social/behavioral science;

(IV) eight semester hours of mathematics; and

(V) eight semester hours of natural sciences.

(ii) An additional 11 semester hours of credit from courses classified as general education within the Comprehensive Articulation Agreement.

(F) Associate in Fine Arts in Music: An associate in fine arts in music program shall include a minimum of 25 semester hours of credit from courses classified as general education within the Comprehensive Articulation Agreement from the Combined Course Library, including:

(i) a minimum of 22 semester hours of credit from universal general education transfer component courses that shall include the following:

- (I) six semester hours of English composition;
- (II) three semester hours of communications and/or humanities/fine arts;
- (III) six semester hours of social/behavioral science;
- (IV) three to four semester hours of mathematics; and
- (V) four semester hours of natural sciences.

- (ii) An additional 3 semester hours of credit from courses classified as general education within the Comprehensive Articulation Agreement.

(G) Associate in Fine Arts in Theatre: An associate in fine arts in theatre program shall include a minimum of 31 semester hours of credit from universal general education component courses selected from the Combined Course Library, including:

- (i) six semester hours of English composition;
- (ii) nine semester hours of communications or humanities/fine arts;
- (iii) nine semester hours of social/behavioral science;
- (iv) three to four semester hours of mathematics; and
- (v) four semester hours of natural sciences.

(H) Associate in Fine Arts in Visual Arts: An associate in fine arts in visual arts program shall include a minimum of 25 semester hours of credit from universal general education component courses selected from the Combined Course Library, including:

- (i) six semester hours of English composition;
- (ii) six semester hours of communications or humanities/fine arts;
- (iii) six semester hours of social/behavioral science;
- (iv) three to four semester hours of mathematics; and
- (v) four semester hours of natural sciences.

(I) Associate in Engineering: An Associate in Engineering program shall include a minimum of 42 semester hours of credit from universal general education component courses selected from the Combined Course Library, including:

- (i) six semester hours of English composition
- (ii) three semester hours of humanities
- (iii) three semester hours of humanities/fine arts or communications
- (iv) six semester hours of social/behavioral science

- (v) twelve semester hours of mathematics; and
- (vi) twelve semester hours of natural sciences.
- (J) Associate in General Education Nursing: An Associate in General Education Nursing program shall include a minimum of 52 and a maximum of 54 semester hours of credit from general education curriculum courses selected from the Combined Course Library, including:
- (i) six hours in communications.
 - (ii) nine hours in humanities/fine arts;
 - (iii) fifteen hours in social/behavioral sciences;
 - (iv) fifteen to sixteen hours in natural sciences; and
 - (v) seven to eight hours in mathematics.
- (3) Major Hour Requirements are as follows:
- (A) Core: Courses identified as curriculum core courses or core subject areas on the curriculum standard for each program title are required for each associate in applied science, diploma and certificate. These criteria do not apply to local certificate or diploma programs if they are not the highest degree level offered at the college.
 - (B) Concentration: Courses identified on the curriculum standard as required beyond the core for a specific related employment field are required for each program that has been identified as a concentration.
 - (C) Other Major Hour: Other Major Hour Courses shall be selected from prefixes identified on the curriculum standard. A maximum of nine semester hours of credit may be selected from any non-core prefix listed, with the exception of restricted prefixes as noted on the curriculum standard. An unlimited number of semester hours of credit may be selected from core course prefixes as long as the number of hours selected are in compliance with the maximum number allowed for the Other Major Hour category and the program. These criteria also applies to local certificate, diplomas and associate degree programs.
- (4) Other Required Hours: Other required hour requirements are as follows:

- (A) Courses that meet graduation or local employer requirements may be included in a certificate, diploma or associate in applied science program of study with the following range of semester hours of credit:
- (i) Certificate: Maximum of one semester hour of credit.
 - (ii) Diploma: Maximum of four semester hours of credit.
 - (iii) Associate in Applied Science: Maximum of seven semester hours of credit.
- (B) Courses designated as college transfer may be included in the Other Required area of college transfer programs with the following range of semester hours of credit:
- (i) Associate in Arts, Science and Engineering: A minimum of 15 semester hours of credit. One semester hour of credit may be included in a 61 semester hours of credit program of study. The transfer of this hour is not guaranteed. The receiving senior institution will determine the transferability of the course.
 - (ii) Associate in Science: A minimum of 15 semester hours. One semester hour of credit may be included in a 61 semester hours of credit program of study. The transfer of this hour is not guaranteed. The receiving senior institution will determine the transferability of the course.
 - (iii) Associate in Engineering: A minimum of 18 semester hours of credit. One semester hour of credit may be included in a 61 semester hours of credit program of study. The transfer of this hour is not guaranteed. The receiving senior institution will determine the transferability of the course.
 - (iv) Associate in Fine Arts in Theater and Visual Arts: A minimum of 16 semester hours of credit. One semester hour of credit may be included in a 61 semester hours of credit program of study. The transfer of this hour is not guaranteed. The receiving senior institution will determine the transferability of the course.
 - (v) Associate in Fine Arts in Music: A minimum of 34 semester hours of credit. One semester hour of credit may be included in a 61 semester hours of credit program of study. The transfer of this hour is not guaranteed. The receiving senior institution will determine the transferability of the course.

(5) Selected Topic and Seminar Courses: Selected topic and seminar courses are designed to be temporary courses and shall be revised each semester. Selected topic courses provide an opportunity to explore areas of current interest in specific program or discipline areas with an emphasis on subject matter appropriate to the program or discipline. Seminar courses provide an opportunity to explore topics of current interest with an emphasis on the development of critical listening skills and ability to critically analyze issues to establish informed opinions. Courses designed to be long-term shall be submitted for inclusion in the Combined Course Library. Selected topic and seminar courses may be included in the Other Required Hours as defined in 1D SBCCC 400.10(e)(4) of a program of study with the following range of semester hours of credit:

(A) Certificate, Diploma and Associate in Applied Science: Maximum of three semester hours of credit for both selected topics and seminar courses.

(B) Associate in Arts, Science, Engineering, and Fine Arts in Music, Theatre and Visual Arts: Maximum of one semester hour credit, utilized as the 61st hour, for both selected topic and seminar courses. The transfer of this hour is not guaranteed. The receiving senior institution will determine the transferability of the course.

(C) Associate in General Education. Maximum of three semester hours of credit for both selected topics and seminar courses.

(D) Associate in General Education Nursing: Selected topic and seminar courses may not be included.

(6) Work-Based Learning:

(A) Work-Based Learning is the development of job skills and an opportunity for career exploration by providing the ~~non-captive or non-special~~ credit curriculum student with employment that is coordinated with the educational program. Credit of one semester hour is awarded for each 160 hours of Work-Based Learning i.e., WBL curriculum prefix courses. Work-Based Learning curriculum courses may be included in a program of study with the following range of semester hours of credit:

(i) Certificate: Maximum of two semester hours of credit

- (ii) Diploma: Maximum of four semester hours of credit. Students participating in an apprenticeship registered under the State's Apprenticeship Program may use up to sixteen semester hours of credit in the diploma program.
- (iii) Associate in Applied Science: Maximum of eight semester hours of credit. Students participating in an apprenticeship registered under the State's Apprenticeship Program may use up to sixteen semester hours of credit in the associate in applied science program.
- (iv) Associate in Arts, Science, Engineering and Fine Arts in Music, Theatre and Visual Arts: Maximum of one semester hour credit which may be utilized as the 61st hour.
- (v) Associate in General Education: Maximum of seven semester hours of credit.
- (vi) Associate in General Education Nursing: Work-Based Learning shall not be included.
- (B) The following are required components for offering Work-Based Learning curriculum courses:
- (i) A college faculty coordinator or college work-based learning director shall plan and coordinate student activity in Work-Based Learning
- (ii) The employer is responsible for the supervision of the student on the job.
- (iii) If a Work-Based Learning curriculum course is required for program completion, the Work-Based Learning curriculum course must be included in a program of study which has been approved by the System Office.
- (iv) Students shall meet age and employment requirements established by the State's Apprenticeship Program-North Carolina Department of Labor.
- (v) A college shall utilize work-based learning (i.e., WBL curriculum prefix) course information as listed in the Combined Course Library.
- (vi) Consultation between the college representative, employer, and student must occur during the Work-Based Learning experience. Each Work-Based Learning student must receive one mandatory site visit for consultation by college faculty or the work-based learning director. Alternative methods of consultation with the employer and student may be

utilized if a physical visit is not feasible as determined by the college faculty or work-based learning director responsible for the site visit.

- (vii) Students enrolled in Work-Based Learning curriculum courses must be enrolled in an approved curriculum program which includes WBL prefix curriculum course(s).

(C) Colleges must retain a file for Work-Based Learning students that contain the following items:

- (i) A current student transcript or Final Grade Report;
- (ii) A student time/wage report worksheet;
- (iii) A completed Work-Based Learning application;
- (iv) A measurable learning outcomes (MLOs) worksheet or a job description.

The MLOs are agreed upon experiences that the student will obtain while working. The job description must contain a list of general tasks, or functions, and responsibilities of a position. The employer, college faculty, or work-based learning director, and the student must develop the MLO within the first two weeks of employment. The student, employer and the faculty coordinator (or Work-Based Learning director) shall sign the MLO worksheet. The minimum number of MLOs that must be completed and evaluated are:

- (I) 160 contact hours (1 Semester Hour Credit) = 1 MLO
- (II) 320 contact hours (2 Semester Hour Credits) = 2 MLOs
- (III) 480 contact hours (3 Semester Hour Credits) = 3 MLOs
- (IV) 640 contact hours (4 Semester Hour Credits) = 4 MLOs

- (v) Documentation of an employer evaluation; and
- (vi) Documentation of employer consultation.

Colleges may substitute an apprenticeship agreement in lieu of requirements in 1D SBCCC 400.10(e)(6)(C)(iii-vi) for individuals enrolled in a college program who are participating in an apprenticeship agreement.

(D) Budget FTE

- (i) Work-Based Learning curriculum courses shall earn budget/FTE at the 100 percent rate of assigned Work-Based Learning hours and shall not exceed

a maximum of 320 membership hours per student per semester. Students that are participating in a registered apprenticeship program through the State's Apprenticeship Program shall not exceed 640 membership hours per student per semester.

(ii) Students shall meet class membership requirements and shall also begin the Work-Based Learning experience before a college may claim class hours for budget FTE.

(iii) The college is responsible for assuring that Work-Based Learning experiences are established prior to the beginning of the Work-Based Learning course. The college may report Work-Based Learning activities either as membership hours or contact hours if the following criteria are met:

(I) A student is considered to be in class membership when the student meets the following criteria: enrolled as evidenced by payment of applicable tuition and fees, or obtained a waiver as allowed for in G.S. 115D-5(b); attended one or more classes prior to or on the 10 percent point in the class; and has not withdrawn or dropped the class prior to or on the 10 percent point.

(II) Contact hours. Students may begin and end the Work-Based Learning at any time during the semester or term enrolled. The college reports only the contact hours that the student actually worked within the term.

(III) Work-Based Learning Orientation. In situations where a college chooses to offer a Work-Based Learning orientation, no more than two contact hours of Work-Based Learning orientation may be counted toward the student's work-based learning experience hours. The orientation may occur prior to the beginning of the semester (although those hours may not be counted towards FTE) provided that the college has a written policy for such services.

Information: The State Board of the North Carolina Community College System, through delegated authority to the System President, approved the curriculum standard revision listed below:

Curriculum Program: Associate of Fine Arts in Music (A10700)

Revision: Add MAT 152 Statistical Methods I and MAT 271 Calculus I to the mathematics options.

Rationale: This change will align with math requirements for Associate in Fine Arts in Visual Arts (A10600) and Associate of Fine Arts in Theatre (A10800) keeping the Associate in Fine Arts programs consistent. The existing Career and College Promise pathway (P1072C) already includes MAT 152 and MAT 271 so the proposed changes align with the CCP and parent programs.

Information: The State Board of the North Carolina Community College System, through delegated authority to the System President, approved the curriculum standard revision listed below:

Curriculum Program: Advanced Medical Coding (D45530)

Revision: Revise curriculum description for entry requirements.

Rationale: Per the current curriculum description, enrollment in this program is limited to graduates of an associate degree in a healthcare field or health informatics from a regionally accredited college or university. The proposed revisions will provide colleges the opportunity to offer the program to a greater student population by removing this requirement, which has been a barrier for enrollment. This change is in line with industry standards as the professional association, American Health Information Management Association, recently released a microcredential in coding that is very similar to the curriculum standard and does not require any entry requirements. In addition, this curriculum standard will continue to meet credentialing requirements for the Certified Coding Specialist (CCS) and Certified Coding Specialist-Physician (CCS-P) by removing this requirement.

Background: 1D SBCCC 400.9 (b) states:

A revision of an existing curriculum standard shall:

- (1) Have written concurrence by two-thirds of colleges approved to offer the curriculum program; and*
- (2) Be in alignment with criteria outlined in 1D SBCCC 400.10(e).*

Title 4 – APPRENTICESHIPNC**

CHAPTER B. EQUAL EMPLOYMENT OPPORTUNITY IN APPRENTICESHIPS

4B SBCCC 100.1 – Adoption of Federal Rules Regarding Equal Employment Opportunity in Apprenticeship
