# **Workforce Development Pinnacle Awards**

This award recognizes outstanding employers, businesses, or industry groups that show exceptional commitment to employee professional development and the advancement of North Carolina's workforce through partnerships with the 58 community colleges in the North Carolina Community College System. Eligible partnerships should demonstrate decisive involvement and firm commitment to workforce development programs, contributing to the enhancement of employee skills and job training. These collaborations should result in significant benefits to the community or regional and state economic development.

### **Eligibility Parameters for Pinnacle Business Awards**

General Eligibility:

- Business Size:
  - Large Business: Businesses with 500 or more employees.
  - o Small Business: Businesses with fewer than 500 employees.



- Apprenticeship: Organizations that actively participate in apprenticeship programs in partnership with community colleges.
- Innovative Business: Businesses that demonstrate innovative approaches or practices in partnership with community colleges.

# Partnership Requirements:

- Active Engagement: The business must have an active and ongoing partnership with one or more community colleges in North Carolina.
- Documented Impact: The partnership should show documented outcomes in terms of workforce development, training programs, or other measurable impacts.
- Sustained Effort: The partnership should have been in place for a significant period, typically at least the past three years, though longer-term collaborations are encouraged.

# Specific Criteria for Categories:

- Apprenticeship: Businesses that provide apprenticeship opportunities and collaborate with community colleges to offer training and job placement for students.
- Business Larger than 500 Employees: Large businesses that have made significant contributions to workforce development through their partnership with community colleges.
- Business Less than 500 Employees: Small to medium-sized businesses that have shown exceptional impact through their collaboration with community colleges.
- Innovative Business: Companies that have implemented novel or creative strategies in their partnership with community colleges, demonstrating outstanding innovation in workforce development.

#### Additional Considerations:

- Previous Award Winners: Previous winners of the business award in the same category are ineligible for nomination.
- Sponsorship Conflicts: Businesses that serve as sponsors of the awards may still be eligible for nomination, provided there is no conflict of interest.
- If a nominated business is affiliated with any member of the Awards Committee, that member(s) will recuse themselves from the selection process. The Chair of the State Board of Community Colleges will assign replacement board members to the Committee if necessary.
