Web-Safety NCID Set Up

- Before a technician can be added to a Safety-Only inspection station the technician must obtain a NCID number on the state system.
- The technician can register for a NCID account by visiting <u>https://ncid.nc.gov/</u>
- Once the technician opens the NCID web page they can begin the process by selecting "To register for a new NCID account click here: Register!"




