Purpose

This report provides an update for the Enterprise Resource Planning Modernization Program.

Background

On March 29, 2023, NC Community College System signed Amendment 4 to the ERP Enhancement and Support Services Agreement (RFQ 50-NCCCS-05112017) to provide modern technologies using the Ellucian Banner® Standard Technology Platform. These modern systems include:

- The System Office Applications for the Combined Course Library (CCL), College Budget and Accounting System (CBAS), Customized Training, and the Data Warehouse.
- A standard student information system template providing student services, core financial management, grant management, human resource management, and payroll systems for colleges.

Timeline

Phase 1 (July 2016 – Oct 2017)

Document business requirements for community colleges

Phase 2 (July 2018 – March 2025)

Establish enterprise solution for online registration of workforce development courses

Phase 3 (August 2020 – February 2023)

Proof of Concept to confirm Banner Standard Technology Template meets business requirements

Phase 4 (January 2023 – December 2025)

Implement Combined Course Library, College Budget and Accounting System, Customized Training, Data Warehouse, and standard student information system template for five community colleges using the Ellucian Banner® Standard Technology Platform.

Phase 5 (January 2026 – December 2028)

Implement standard student information template at community colleges.

Status

- Phases 1, 2 and 3 are complete.
- Phase 4: Amendment 4 to the ERP Enhancement and Support Services Agreement (RFQ 50-NCCCS-05112017), signed March 2023, established Phase 4. System Office application contract commitment dates agreed to in Amendment 4 were not met. Amendment 5 signed December 2024, revised contract commitment dates for the System Office applications.
- **Phase 5** is in the planning phase.

- Public Website View 90% complete. Remaining 10%: testing, training and publication.
- Curriculum Management 40% complete. Remaining 60%: configuration, testing, and implementation.

Data Warehouse - 75% complete

- Remaining 25%: testing, performance optimization and promotion to production.

Customized Training - 100% complete

- This application is currently in production use.
