

**AMENDMENT 10 TO NOTICE OF EXTENSION OF ITS-005997 (001) (ITS-009797)**

THIS AMENDMENT (Amendment 10) is given by North Carolina Community College System, 200 West Jones, Raleigh, NC 27603 (NCCCS) to SHI International Corp., 290 Davidson Ave, Somerset, NJ 00873 (Vendor).

The parties acknowledge they entered into a contract, ITS-005997, in February 2013 to provide maintenance and support for Microsoft Software subscriptions through the Microsoft Consortia for the North Carolina Community College Constituent Institutions (AGREEMENT).

The parties executed the first renewal option to extend the term of the AGREEMENT for the period beginning April 1, 2016 through March 31, 2017 (Amendment 1).

The parties acknowledge they amended and extended the AGREEMENT for the period beginning April 1, 2017 through March 31, 2018 (Amendment 2) and amended the Limitation of Liability and Default sections in the Terms and Conditions of the AGREEMENT.

The parties acknowledge they amended and extended the AGREEMENT for the period beginning September 2018 to extend AGREEMENT from October 1, 2018 through June 30, 2019 and amend it to reflect a new discount pricing structure (Amendment 3).

The parties acknowledge they amended and extended the AGREEMENT for the period beginning July 1, 2019 and ending June 30, 2020 (Amendment 4)

The parties acknowledge they amended and extended the AGREEMENT for the period beginning July 1, 2020 and ending June 30, 2021 (Amendment 5).

The parties acknowledge they amended and extended the AGREEMENT for the period beginning July 1, 2021 and ending June 30, 2022 (Amendment 6).

The parties acknowledge they amended and extended the AGREEMENT for the period beginning July 1, 2022 and ending June 30, 2023 (Amendment 7).

The parties acknowledge they amended and extended the AGREEMENT for the period beginning July 1, 2023 and ending June 30, 2024 (Amendment 8).

The parties acknowledge they amended and extended the AGREEMENT for the period beginning July 1, 2024 and ending June 30, 2025 (Amendment 9).

Now the parties agree to amend and extend the AGREEMENT for the period of July 1, 2025 through December 31, 2025 with the option to renew for two (2) three-month extensions.


Both parties agree that this is the final extension, and the AGREEMENT cannot be extended in a future amendments or modifications.

Except as amended hereby, all other Terms and Conditions of the AGREEMENT and Amendments remain unchanged.
