Allocation of Title II, Adult Education and Family Literacy Act (AEFLA)
Section 243, Integrated English Literacy and Civics Education (IELCE)
FY 2025-2026

Request: The State Board of Community Colleges (SBCC) is requested to approve the federal Workforce and Innovation Opportunity Act (WIOA), Title II Section 243 funding allocation for 31 Integrated English Literacy and Civics Education (IELCE) programs in the amount of \$1,395,527.

Strategic Plan Reference: Goal 4: Economic and Workforce Development
Provide education, training, and credentials to develop the most competitive and agile workforce in the nation.
Strategy: 4.1

Background: IELCE programs must be provided in combination with Integrated Education and Training (IET) activities and be designed to: (1) prepare adult English language learners for, and place in unsubsidized employment in in-demand industries and occupations that lead to economic self-sufficiency; and (2) integrate with the local workforce development system and its functions to carry out the activities of the program.

Method of Allocation: Title II WIOA Section 243 funds are distributed by the North Carolina Community College System according to a formula adopted by the SBCC in July 2019. The formula has three components:

1. **Base:** 70% of available funding is allocated equally among providers.
2. **Participation:** 10% of available funding is allocated based on the provider's share of participants. That share is multiplied by a dedicated allotment to determine provider allocation. Participant is defined as an individual in a Title II program who has received at least 12 hours of service in a Period of Participation (POP). The participation component is available only to providers who have submitted 2023-24 data.
3. **Performance:** 20% of available funding is allocated based on the provider's share of Measurable Skill Gains (MSGs). That share is multiplied by a dedicated allotment to determine provider allocation. The performance component is available only to providers who have submitted 2023-24 data.
