**TITLE 4 – APPRENTICESHIPNC**



## **CHAPTER A. GENERAL PROVISIONS**

## 4A SBCCC 100.3 Definitions

The definitions listed in 29 CFR 29.2 shall apply to terms found in the federal regulations administered by ApprenticeshipNC, as listed in 4A SBCCC 100.1. Other definitions that apply in this Chapter are as follows.

- 10 (a) Director – The Director of ApprenticeshipNC.
- 11 (b) Registration – The recognition by the Director and the recording with  
12 ApprenticeshipNC of an apprenticeship, apprenticeship agreement, or an  
13 apprentice signifying that the program, agreement, or individual complies with the  
14 rules, requirements, criteria, and standards of this Chapter.
- 15 (c) Related Instruction – An organized and systematic form of instruction designed to  
16 provide the apprentice or trainee with knowledge of the theoretical and technical  
17 subjects related to their trade or occupation. Such instruction may be given in a  
18 classroom, through occupational or industrial courses, by correspondence  
19 courses, through electronic media, or through other forms of self-study.
- 20 (d) Revision – Any substantive modification or change of the program standards of  
21 apprenticeship (including an affirmative action plan and a written description of  
22 the selection procedure) or of an apprenticeship agreement.
- 23 (e) Standards – The program standards of apprenticeship as set forth in 29 CFR 29.5.
- 24 (f) Technical Assistance – Guidance provided by ApprenticeshipNC staff in the  
25 development, revision, amendment, or processing of a potential or current program  
26 sponsor's Standards of Apprenticeship, Apprenticeship Agreements, or advice or  
27 consultation with a program sponsor to further compliance with this Chapter or  
28 guidance from ApprenticeshipNC on how to remedy nonconformity with this  
29 Chapter.

1        (g) Pre-Apprenticeship Program – A training model designed to assist individuals who  
2        do not currently possess the minimum requirements for selection into an  
3        apprenticeship program, to meet the minimum selection criteria established in a  
4        program sponsor's apprenticeship standards as required under applicable federal  
5        regulations, and which maintains at least one documented partnership with a  
6        Registered Apprenticeship program. It involves a form of structured workplace  
7        education and training in which an employer, employer group, industry  
8        association, labor union, community-based organization, or educational institution  
9        collaborates to provide formal instruction that will introduce participants to the  
10        competencies, skills, and materials used in one or more apprenticeable  
11        occupations.
