Purpose	Vendor shall provide thorough field labeling evaluation services of unlabeled & non-certified equipment, product safety testing and provide certification and labeling of products, equipment, or systems to ensure the safe operation of equipment by students and faculty. The vendor will provide the college documentation of compliance for their file.
Inspection Requirements	Vendors will provide third-party inspection to any of the 58 Community College locations within the State of North Carolina. Vendors are requested to complete inspections within ten (10) business days after receipt of a purchase order.
Re-Inspection	If a piece of equipment owned by a State Agency failed an initial inspection, has been relocated, or has a need for reinspection based on other circumstances, the awarded Vendor(s) shall charge a reinspection fee of 25.0% off the Vendor's originally approved inspection fee
Inspection Reporting	The Vendor shall complete and submit the final inspection report to the participating Community College within three (3) business days after inspection completion.
Discounts	If a State Agency requires inspections on multiple pieces of identical equipment, the inspection fee shall be discounted by 50.00% .
