I. PURPOSE STATEMENT

G.S. 115D-5(a) provides that “[t]he State Board of Community Colleges may adopt and execute such policies, regulations and standards concerning the establishment, administration, and operation of institutions as the State Board may deem necessary ... to provide for the equitable distribution of State and federal funds to the several institutions.” G.S. 115D-31(a) further describes the State Board’s responsibility to provide, “from sources available to the State Board,” financial support to the institutions.

It is the responsibility of the colleges to ensure that State and Federal funds are expended consistently with the policies herein.

II. CARRYFORWARD ALLOCATIONS FROM FY 2024-25

A. Competency-Based Education Carryforward

Purpose: The purpose of the funding is to expand the alignment of workforce-focused learning to courses within the Common Course Library via a Competency Based model. CBE is a form of academic evaluation that focuses on skill mastery through clearly defined outcomes, not on time spent in the classroom. It measures student knowledge and skills with competency completion through project-based learning and aligns them with equivalent learning outcomes.

This project is a joint effort between Wilkes Community College (WCC) and Fayetteville Technical Community College (FTCC), with WCC serving as the project and finance lead college.
